#### Attention Members Major Project Summary 2020

The BOD has settled on range improvements for the 2020 construction season. Heavy emphasis was placed on ADA compliance projects and drainage issues. A summary of the projects is presented below for membership approval at the next membership meeting.

- ADA compliance projects generated by a certified consulting engineering firm on our facility.
- Total ppty drainage assessment by a hydrologist.
- Grading and back fill as required for drainage.
- New roof on 25 and possibly 50 yd range.
- Safety modifications to Trap house #1.
- Road and parking lot upgrades.

Because the planned expenditures will surpass the bylaw set limit of \$75K there will be a ratification vote by the membership at the March meeting. Since we do not have a good handle on the individual costs of each project, at this time, the vote will be a blanket approval vote to cover the total improvement budget.

### RSO Scheduling

The range will open to the public on the first weekend after the Fourth of July. Scheduling of RSO dates will tentatively be on or about April first. Watch for more information in future newsletters.

### Note from the VP March 2020

Many changes have taken place in the past month. The past president has withdrawn for personal reasons, which places the vice-president into that position via the bylaws. This creates a vacancy in the position of VP, which must be filled by a selection of the BOD. If you wish to contribute to the Club in this capacity please contact the secretary at sec@oakdalegunclub.org prior to the March BOD meeting.

After consulting with two law firms the club has contracted an engineering firm specializing in ADA compliance law to evaluate our facilitv for conformance. That firm reviewed our total facility in early February and will do it again when the snow is gone. The BOD has committed \$50k of funds in 2020, to make our ranges compliant with ADA regulations. The Long-range Planning Director will be coordinating all activities in this regard and will maintain a communication link with the members.

Planning accomplishes no tangible improvements unless members come forward to oversee each project. If you are interested in assisting this club move forward and at the same time fulfilling your work requirement contact VP@oakdalegunclub.org.

Needed are several volunteers to research drainage consultants, grading contractors and roofing contractors, among others.

### Oakdale Gun Club Member Meeting Feb 12 2020

Meeting opened at 7:00 PM by Vice Pres Tom Mader Pledge was said.

Attendance at the meeting was 30.

At the start of the meeting the President explained there is a door prize based on the numbers on the sign in sheet.

**Secretary** read the minutes from the January member and Board meetings. A **Motion** was made and seconded to approve both minutes as read. All voting aye no opposed.

**Trap Director:** Prior to the member meeting a vote was taken by the Board to appoint Daryll Olson to the Trap Director position with a majority voting aye. Daryll came before the membership as the Board Appointed candidate for the new Trap Director position. Prior to the vote by the membership, as required by the Bylaws, he gave a brief bio of his qualifications. A vote was then taken with a majority voting aye for Daryl as Trap Director. Teresa indicated there is no formal definition on the trap position in the Bylaws. This will be addressed by the Board.

**President:** Bob Ries has tendered his resignation as president for personal reasons. Tom gave the procedure per the Bylaws for the Vice President to take over the President position. A new person can then be appointed by the Board as Vice President for the remainder of this year. This will be handled at the Board meeting. Tom indicated His goal will be to put the agenda out 2 weeks prior to the meeting

**ADA evaluation**: Tom indicated we talked to two lawyers about the ADA requirements. They recommended hiring a company which we contacted to inspect the range and give us their recommendations. The people for ADA inspection came to the range and met with Teresa and only looked at the buildings due to the snow. We have about \$50,000 allocated to make changes. Teresa gave a brief report on what has happened to date. They looked at the buildings and will look at the rest of the range later and will write a report then. She mentioned the ramp to the club house and toilets need to be updated for ADA compliance. Teresa also spoke on the current idea of bringing in trailers for our Toilet requirements The ADA people cautioned us on the trailers as they may not meet Minnesota requirements. Teresa also talked on the parking requirements and indicated they may meet Wisconsin requirements but not Minnesota.

Annual Picnic: Tom discussed the picnic this year and what had happened. People did not like the food and that will change this year. Also maybe pick a different time for the picnic. The day last year had problems with daylight and was also small game opener so should hold it earlier in the year. A recommendation was made to move is back to the previous time.

**GM:** Teresa received a thank you from Washington Co. Sheriff for the Vests for K9. They had just bought new vents and would use the donation for training. The membership renewals are in and the count is 1220 renewed so we lost 227 members. This is about the same as previous years as we usually loose about 200 to 250 member each year. Please let her know if you have anyone that would like to join OGC this year and she will get a new member form to them. We have about 150 on new member list.

New member training is scheduled for March 19, 21, 28 29.

Lead NRA RSO training class is scheduled for Monday March 9 and Monday March 16 from 6 to 10PM You must attend both nights and must register for this class with a deadline of March 1. For members there is no charge. Nonmembers are charged \$60. There might be a slight delay as NRA has had printer problems The Woman's class is also scheduled for Wed April 29 classroom and Saturday May 2 from 9 to 5. Had the hazardous waste inspection and we passed with flying colors.

Need 2 people to snow blow target area on ranges for the month of March. Please if you shoot on the short range and use large paper targets please put them in the trash bins by the house.

**Pheasants Forever**: Jeff Martin. Would like range passes for the event on March 5...**Motion** made to give him 10 passes seconded all voting aye.

**Dean Cody** asked about training at the club for Stop the Bleeding for injuries at a gun club. The Board will look at this at the Board meeting.

Richard indicated store open and needs orders to send in.

**Door prize for \$20** was then drawn using poker chips and the numbers on the sign in sheet. Tom Acheson won

This would make the renewal work easier and would be a considerable cost saving. Tom would like Patrick to do a written proposal to get this started. Emergency calls: accidental call for 911 last year resulted in people not able to get into the club. Patrick made cards for Sheriff Dept. to access club. The cards will be in the Squad cars.

# **2020 Introduction to Firearms for Women**



Do you want to learn about handguns, rifles and shotguns?

This 1 evening + 1 day informational workshop, taught by certified safety instructors, is a way for Women to get their basic questions about firearms answered in a safe, friendly, casual, women-only classroom environment. Note: Instructors include both Female and Male.

The workshop consists of one evening and one full day: evening is classroom discussion and Saturday morning is "hands on". Then experience an afternoon of live fire range time on Saturday afternoon.

You do not need to have any previous shooting experience to take this class or own a firearm. A wide variety of firearms will be provided at no extra cost for those who wish to try them during the range session. This course neither promotes the ownership of firearms nor will any be offered for sale during the course. This class is open to the public. You must be at least 18 years of age to take this class, unless accompanied by a parent. Other restrictions may apply.

The cost of this course is \$50.00 (includes: class materials, firearm rentals and ammo) and must be prepaid to hold your registration. The class is limited to 30 women on a first come basis. This class is only held once a year.

The 2020 Class has been scheduled.

Wednesday April 29<sup>th</sup> from 5:30 pm to 9 pm in the classroom at OGC Saturday May 2<sup>nd</sup> from 9:00 am-12:00 pm "hands-on" in the classroom. Lunch break will be 12 pm-1 pm ( bring your own or leave for lunch). Class starts promptly at 1 pm. 1:00 pm to 5:00 pm shoot one-on-one with instructors on the range.

You must attend both Wednesday evening and Saturday's morning class to be able to shoot on the range Saturday afternoon.

### WHAT IS THE POSTAL MATCH??

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / her shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this:

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2019.

Lever Action @ 100 Yards, scope, timed fire.
Lever Action @ 100 Yards, iron sights, timed fire.
Rimfire Rifle @ 100 Yards, any sight, timed fire.
Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
Varmint Rifle @ 200 Meters, scope, timed fire.
Varmint Rifle @ 200 Meters iron sights, timed fire
Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.

#### The Clinic will include the following:

- Starting in the classroom.... The history of Bullseye, firearms, equipment and accessories, course of fire, commands, stance, position, grip, breath control, sight alignment, trigger control and scoring.
- Talk about the match schedule
- Move to the competition range for a 22 cal National Match Course (10 rounds slow fire at 50 yards, 10 rounds timed fire at 25 yards, 10 rounds rapid fire at 25 yards)....one participant at each firing point, coaches for each participant will be assigned. Bring your own equipment, or shoot with your coaches equipment.
- Centerfire / 45 ACP National Match Course (same course of fire as above).
- End of clinic, but feel free to stick around if you want more practice.

The focus will be on participants who have not shot a Bullseye match before (and may, or may not, be experienced with a pistol or rifle). We will assign a coach to each participant to provide more individual instruction. Please bring eye and hearing protection, ammo, a 22 cal or / and a 45 acp pistol if you have one. If not, we should have some extras.


