## Oakdale Gun Club Board Meeting

October 14 2020

Meeting opened on ZOOM at 7:30 PM there were 11 Board members and Teresa in attendance. Not present was Tom E, David D and Dan B.

**Glock Match:** Mike Murphy and Jim Finch asked to attend the meeting to report on results of the Glock Match. Jim started with reporting 208 registered for the Glock Match. A check for \$1075.48 was given to Teresa for deposit. Mike Murphy submitted the paperwork for service hours. The Washington County explorers handled the concessions with detective Sara Pauline, the Troop leader. They have been invited back the weekend before the Deer opener. Mike stated the RO's were great in running the match. Mike indicated they finished the matches with a handicap this year as they shot only 5 USPSA Thursday nights matches with 430 shooters. Of these shooters there were 237 OGC members. Net income was \$2112 for the Thursday Night matches for the year. Mike indicated he had been absent for several of the matches due to a physical problem so this is his last year. He is retiring from being match director. He indicated he would suggest using Joe Griffin as Director as he has been his partner for the matches the last 10 years. Also Jim Finch has helped for a long time for the State matches. Thank You to the Board for the help he received from the Board during his time. The Board thanked Mike for his hard work and excellent job.

**Finance:** Bill, the Club is doing extremely well so far this year. There has been no reduction in the income for this year. We anticipate more income from the range and from the Membership dues before the end of the year.

**Security:** Patrick, He has received a response form Lloyd. They want to meet again and update our system. He is optimistic they will upgrade the system. Neil asked about testing the system in the spring with leaves on the trees to be sure everything works going forward.

ADA: Herb, Talked with Troy and he is not available until mid-November which also will be when we are closed to the public. There is a lip on the door to the classroom that needs to be ADA compliant We will pull out \$1500 worth of concrete work to be done next year. We are looking at about \$8500 worth of work on the 100 and comp range lanes to the targets. The Board would like to get a listing of the ADA work needs and other work before starting. Neil indicated he would like estimates on the work. Herb has some estimates on some work to be done using concrete. Daryll listed some safety issues that need to be done on the trap range and also ADA requirements for trap 1. Discussion followed on the issues that are ADA and non ADA. Neil wanted a list of the additional work to be done and the priority assigned to it. Herb will send a list to the Board to review before next Board meeting. Daryll will also send a list of the Trap work to be done.

**RSO work hours:** Tom Mader asked about work on the range being approved. Teresa responded, she is Recording all the work being done and is in control of the projects.

**Board Openings:** There are 2 openings not filled for the Ballot Newsletter and Youth. We need to send an Email blast to fill the openings. Not all Board members have responded and sent in pictures and info for input in the newsletter.

**Spacing on ranges:** using all benches and ranges to be sure of spacing. Extra RSOs are used during high demand. Social distancing will be followed. The President instructed the GM she can use all benches when needed and be sure to maintain social distancing.

**Board Info:** Board members should come to the 7AM RSO instruction to hear the information given. A fantastic job is being done on instructing RSO and running the range.

**Annual Meeting:** Member asked about using ZOOM for the Annual meeting. The Board responded they would not be able to interact with several hundred people on ZOOM.

**Charlie Ames** reported former member Dave Carlson died of Covid.

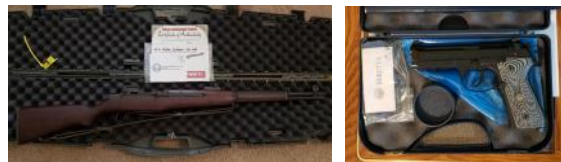
