Notes from the President AUG 2020

The Board of directors has been busy maintaining the functions of the Club during the lockdown and subsequent limited opening. Through the utilization of Zoom and Email technology we have maintained an active maintenance and management of the organization. Due to the Governor's limitations on meetings the BoD established a procedure for accomplishing the goals of the annual meeting. The election of the Board of Directors will be conducted in several steps by mail; as explained in this newsletter. The policy manual is being expanded to include two new topics. One defines the use of scooters on the property and the other lays out the duties and responsibilities of a gate guard. These addendum sheets will be sent eBlast and will be available on our web site.

In the past there has been confusion as to use of a gate guard when the Club was not open to the public yet the main gate remained open for various member events and or trap activities. In the coming year we will be able to schedule a gate guard for all events online. This should increase our security by preventing non-members from accessing our facilities during closed periods.

This first month of public shooting on weekends has been very busy. Volume of range receipts exceeds previous years. If the Governor does not limit us and the weather holds out we may have a very successful year where it looked gloomy early on. Social distancing and mask usage must be maintained by the Governors decree.

Online scheduling of RSO service hours had a delayed start. Once initiated, it went great guns. Thanks to many hours of intense work by our Newsletter Director, doing triple duty of implementing new scheduling software, assisting with the updating of the web site along with his newsletter duties, the online schedule filled up rapidly. Many thanks for the huge volunteer effort in doing those tasks so very well!

A reminder to all Range Safety Officers (RSO): Your obligation starts at 7:00 AM and is a full nine hours. Half-day obligations are not allowed for security and scheduling reasons. The first hour is a debriefing in the registration building by the General Manager or Lead RSO to set up the safety and management for the day. If you have a legitimate medical issue and cannot serve a full shift contact the Secretary for resolution

Oakdale Gun Club Board Meeting

August 12 2020

Meeting opened on ZOOM at 7:30 PM.

There were 12 Board members and Teresa in attendance. Not present was Tom A, and Gail.

Finance: Bill, we are very comfortable financially to the end of this year. He gave an example of the scenario of this year and the outcome. He looks at 3 areas under the microscope which are IT, Building and Grounds, and Security. He looks at the 3 directors of these areas to keep him updated on any spending.

Tom E: update on the Web, we just recently completed another phase with vendor working on the new website. We are entering phases 3 and 4 which includes working on changes to the Email system. Having ability to make changes to the current web site. Neil working on role identities needed on the new web site. Role identities will enable individuals to work on the site to maintain items such as calendars, or articles etc. We will then be doing training for people to interact with the new site. Per Neil the new Service Hour system is not as visual as the current Signup Genius being used this year. There has been lots of activity on the current system with people changing their service dates.

Security: Patrick, The cameras have not been working as of March of last year. Working with Lloyds Security to resolve the problems. Worked with other companies to get an opinion of the system installed by Lloyd. Lloyd has worked with Patrick on issues like the front gate and trap caused by lightning strikes. The current camera system on the ranges were installed using line of sight to an antenna on the Range building. This approach does not work. We don't have functioning cameras on any ranges. We need to implement hard wired cameras using our fiber optic cable we have in the ground. Patrick has tried to work with Lloyd and has not gotten a response. Patrick has obtained legal council with the board's permission and will be following the legal advice.

2021 Badges: Patrick stated we need to move forward with photo badges for next year. We will need to have photos taken of members. Next year we can come up with a new design for the badges and use a sticker to update the badge.

Annual meeting: The club can't have an annual meeting this year due to covid. Tom E has upgrades Zoom to handle 100 people. In the past we have had up to 150 people. Don't have an area large enough to safely distance for meeting. Each Director would have submit a report to be published.

Motion made by Patrick to suspend bylaw change submissions for this year. Daryll seconded motion.

Majority vote aye with no nay. For the election, in the newsletter each director could have a brief report. A procedure with two envelopes can be used to submit ballots for the election. Further details to be sent in November with ballot.

Within the next 4 to 5 days an Eblast will be sent out to get candidates for Board of Director ballot this year.

ADA Disability Mobility: Duane will send out the OGC Disability Policy to the Board for their review.

Tom Mader will set another meeting for Aug 19 at 7:30PM.

Herb discussed a bid from Troy Dalhgren for \$10,000 for range modifications to meet the ADA requirements.

Board members indicated they would like another bid or 2 for the work.

Tom M asked about the type of material needed for the ADA requirements on trails created.

Herb indicated using 2 types of material to build trail.

OGC Special Board Meeting

August 19 2020

Meeting opened on ZOOM at 7:30 PM had problem opening and finally got in at 7:47PM.

There were 12 Board members and Teresa in attendance. Not present was Tom A, Tom E and Dan Burkhart .

Finance: Bill gave the finance report. We should be OK thru the end of the year. Discussed what to do not having an Annual meeting this year. Discussed how to have an election this year and procedure to follow for mailing out ballots. Neil commented on work to print and send out the ballots, and the cost.

Decision was made to not have any Bylaw changes this year due to complications in the process and Covid-19 limitations.

Facebook Presence: David has access to Facebook page along with Michael Schissel. Jorge Vergin also wants to post photos on Facebook. Discussion followed on allowing people to join Facebook. Also, who will manage this media? Jorge and David to monitor Facebook. We look at this as a tool to use to communicate with the public.

ADA update: Herb has a quote from Troy on work to be done on the ADA list. We don't have a second quote as yet for the 100 yd range, comp range, and 50 yd range work. Estimating about \$10,000 for the work. Work completed-so far is seal coating on parking places, signage, and striping .

Glock Match; Match is already locked for September.

Lighting on the range. There are lights on the 25 for testing. Make sure everyone checks the lights and see if it meets our needs. Need to change the conduit on the 50 to place the lights in front of the bench.

Herb Charity shoot: cancelled due to Covid.

Scooter Policy: Duane will re-send out the Disability Mobility Policy to all Board members and Teresa.

Swap Meet: Duane will work on setting up a swap meet on a week day evening in September. There was no opposition to having this event. Tom Mader said to go for it.

Renting the range for Concealed Carry: An instructor inquired about renting the 25yd range for 1 hour (8 to 9am) on Saturday morning September 19. Discussion followed on issues with renting the 25yd range at that time. Neil recommended using the comp range and moving the firing line forward for their use.

Majority of Board voted aye.

Patrick: A member inquired about having a private "Baby reveal party" on the 200meter range in off hours. They would clean up the range after the reveal. This would be private not open to the public. Board OK

Daryll: Trap Target order, would cost about \$15,000 for 12 pallets. Can order half an order to cut cost for this year. Daryll indicated we could get by for 2 months. Put on hold until next meeting.

Daryll will be installing new circuit boards on the traps tomorrow.

Security: Patrick reviewed the steps with the board regarding resolving the nonfunctioning cameras on the ranges.

Gate Guard: There was discussion on setting up scheduling Gate guard service hours online. We currently don't have a formal definition of gate guard responsibilities. Not cost effective to install separate gate. Tom Mader will write a formal Gate Guard policy with Gail's help and send out to the Board for approval ASAP.

Roofing: Bill, The roofing project on the 25 yd range has been completed.

Hudson Raider Shooting Club (HRSC) Finds Success in 2020

OGC members may have noticed some new and different faces around the club this summer. Despite a very late start due to the COVID-19 pandemic, the HRSC was fortunate to salvage a highly successful shooting season this year, thanks to the hospitality and welcoming afforded by the OGC in hosting the team's trap, pistol and rifle practices this year.

The HRSC was formed in 2011 with a nine member squad that has grown over the years to a team as high as 100 members ranging from 4th and 5th graders all the way up to the collegiate level. The team is supported by a large coaching and volunteer staff and is unbelievably lucky to have such a dedicated group assisting the kids. During a normal season, the Raiders shoot a conference schedule, multiple tournaments at varying locations, and State and National Championships in multiple shooting sports disciplines. In 2020, shooting competitions were a bit limited but the team still had opportunities to participate in virtual leagues and in-person state and national championships.

The athletes compete in many different clay target disciplines including 16-yard, handicap, doubles and bunker trap, skeet, doubles skeet and sporting clays through the Scholastic Clay Target Program (SCTP). In addition, the Scholastic Action Shooting Program (SASP) offers the kids the ability to participate in speed action shooting utilizing rimfire pistols and rifles, 9 mm pistol carbines and 1911 style centerfire pistols. Competitors shoot at steel plates in a variety of configurations, all courses of fire are timed events and are conducted in a series of five strings with the lowest score discarded.

In the virtual Wisconsin state pistol/rifle championship in June, the Raiders did extremely well with the open squad placing 1st in rimfire pistol, 2nd in iron sight rifle and 3rd in optic sight rifle. The squad also participated in the virtual National Championships at the end of July. There were 1,656 competitors nationwide and one of the rookie shooters, Jake Burger, placed 7th overall in optic rifle in his division.

A 5-week nationwide virtual competition was available for 16 yard trap through the SCPT as well. The Raiders finished in 10th place out of 74 teams that competed. The 2020 SCTP National Team Championship was held in Marengo, Ohio in July and 14 Raider shooters competed in the event. Lauren Kern (age 14) placed 3rd in doubles skeet, 3rd in handicap trap, 5th in 16 yard trap and 4th in bunker trap in her age division. Izzy Arnett, age 11 and a 1st year shooter, placed 5th in 16 yard trap and a squad competing in the open division for handicap trap earned 2nd place medals.

At the Wisconsin state bunker trap championship, the team finished 7th overall and Lauren Kern finished 3rd in her division. At the Wisconsin state sporting clays championship, the JV squad took 2nd place and Brady Kern finished 3rd individually. At the Wisconsin state trap shooting championship, the intermediate advanced division squad took 1st place and the rookie and JV squads each took 3rd place in 16 yard trap with Izzy and Lauren both taking first place honors in their divisions. At the Wisconsin state skeet championship, the JV squad also was awarded 3rd place.

Karen Johnson, OGC member and Raider coach, said, "This is a very respectful and hardworking group of kids. I'm amazed at how well they did this season, especially given the fact that they had significantly less time to practice than normal. We couldn't be prouder of these young ladies and men."
