## 2020 Presidents Report

This past year was a totally unique year for the OGC in many ways. The year began in a normal fashion until early spring when the virus struck. The Governor shut down all businesses including the use of our facilities to all members. Within weeks the ranges were open but all meetings were prohibited. For the balance of the year the Board of Directors conducted monthly business via Zoom internet meetings which proved effective.

With the uncertainty of a possible future shutdown and the accompanying revenue lose, all future spending was cut to the bone. As a result of the budget reductions the allocated moneys for ADA (American Disability Act) compliance improvements were put on hold. When it became apparent that we would be able to open to the public and a revenue stream would be generated it was too late in the year to establish contracts for the work required. That was a huge disappointment to me personally, for my objective for the year was to evaluate what was needed for complete ADA compliance and move forward on achieving total compliance.

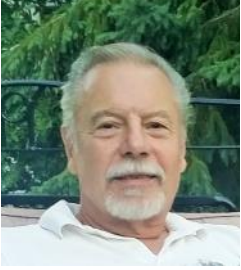
As it worked out the Club maintained an operating scheduled for public shooting and thus completed a safe and successful season. This was only possible because of the combined efforts and dedication of many volunteers. My sincere and heartfelt thanks go out to the many members who unselfishly donated many hours of their personal time to make the OGC the success it was in 2020. 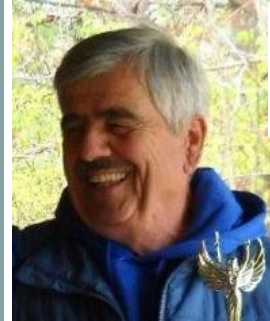

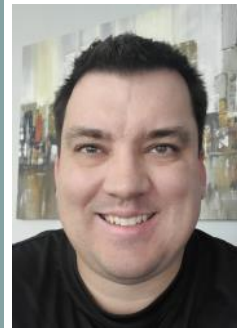

## Annual Board of Director Reports for 2020

### 2020 Safety and Security Report

I know this report is late, but this was intentional. I have been working diligently with Lloyd Security via our counsel to get our video system issues resolved. This has been a long and tedious venture.

Here is where we stand at this point. We currently have 18 cameras functions. The are as follows:

(2) - 25 Yard Range	(2) - 50 Yard Range	(1) - 200 Meter Range
(4) - 100 Yard Range	(4) - Comp Range	(1) - Trap Range
(2) - Classroom	(2) - Clubhouse	

We currently have no cameras working on the entrance, even though they are in place. This is due to the fact that there is no power run to the box mounted on the light pole. There are 2 cameras mounted on the pole and when power is restored to this box, we will have a total of 20 cameras functioning.

Lloyd has moved two of the antennas, on the 50 Yard Range & the 200 Meter range to be outside of the building.

We currently have NO cameras on the Short Range.

Lloyd has agreed to replace the cable that is “not to code” on the 50, 100 & 200 ranges at no cost to OGC.

This year we did have several Access system failures due to what are believed to be lightening strikes. We believe that this was resolved with the installation of “surge protectors” on the affected readers. We also had a complete “Lockdown” which has never been instituted at OGC. While it took a lot of work, it was successful.

Moving forward, I would like to have a few electrical boxes moved and/or added. I would also like to see the installation of cameras on the Short Range and at least one additional camera on the Trap Range.

The goal of having the video system up and running, is accomplished. We will continue to monitor and make corrections as necessary. We also believe that the card system is more protected to prevent future outages due to lightening strikes.

The goal of moving to photo identification badges still lingers. This was put on the back burner to to the Covid-19 issues we have experienced this year. This is still a future goal for OGC.

## 2020 – Legislative Director Report

This has been an interesting year following the Minnesota Legislature. In January, I attended a hearing on proposed gun legislation in Hibbing. Several anti-gun groups were there. The MN Gun Owners Caucus also rallied their members to attend. Both pro-gun and anti-gun proposals were discussed. As you can imagine the attendees were very vocal. I also attended the annual meeting for the MN Gun Owners Caucus in January. Several state representatives were in attendance.

Through the legislative session, numerous gun control proposals have passed through the House. These include expansion of background checks (required for private sale or transfer), Red-Flag firearm confiscation and requiring a Permit to Purchase for each firearm purchase. At least one of the proposals would no longer honor a Permit to Carry as a Permit to Purchase. So far, the Senate has stopped these proposals from reaching the floor for debate.

There were attempts to add gun control language to appropriation bills, but these attempts were met with significant resistance due to the work of the MN Gun Owners Caucus asking their members to contact their representatives.

There have also been several Pro-gun bills proposed. The senate has held off on debating pro-gun legislation as it would open the door for the anti-gun proposals to be debated as well.

Another area affecting our members has been policies delaying the process to apply for or renew a Permit to Carry. In some counties, Sheriffs are requiring appointments to drop off Permit to Carry applications, but not staffing adequate resources to accommodate these appointments in a timely manner. This could lead to expiration of your permit while waiting for an appointment slot. I am not aware of this affecting Washington county, but I expect some of our members from Ramsey and Hennepin county may have been affected. State Statute provides for a 30-day time period for a permit to be processed once it has been given to the Sheriff's office. Requiring an appointment to deliver the application is infringing on our Second Amendment rights.

It appears the 2021 legislature will be similarly split between the House and Senate. I intend to continue supporting Oakdale Gun Club as your Legislative Director.

### WHAT IS THE POSTAL MATCH??

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / hers shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this;

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2021.

The events are:

- Handgun (Revolver) @ 10 Yards, open sights, timed fire.
- Handgun (Autoloader) @ 10 Yards, open sights, timed fire.
- Handgun (Rimfire) @ 10 Yards, open sights, timed fire.
- Handgun Unlimited 100 Yards, any caliber, any sight.
- Lever Action @ 100 Yards, scope, timed fire.
- Lever Action @ 100 Yards, iron sights, timed fire.
- Rimfire Rifle @ 100 Yards, scope, timed fire.
- Rimfire Rifle @ 50 Yards, open/iron sights, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, scope, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
- Varmint Rifle @ 200 Meters, scope, timed fire.
- Varmint Rifle @ 200 Meters iron sights, timed Fire
- Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.
