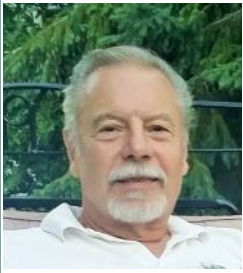

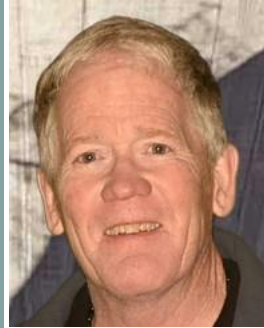

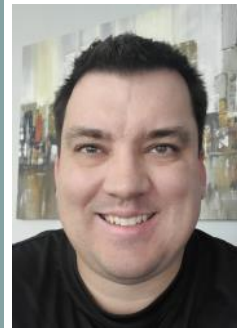

## OGC January Board Meeting Minutes

### OGC Board Meeting

Jan 13, 2021

Meeting started at 7PM hosted by President Tom Mader.

Joining him at the Zoom meeting was: Duane Wilhelm, Tom Baker, Terry Derosier, Charlie Ames, GM Teresa Reiter, Tom Baker, Bill Gacki, Patrick McNeil, Dean Cody, Tom Etzel, Dave Duepner, Herb Owen Gail Angone. Joining later was Tom Schaeffer. Absent were Tom Acheson and Daryll Olson.

Tom Mader introduced the VP Tom Baker, and the Youth Dir Terry Derosier new to the group.

Neil then related his interaction with Tom Schaeffer, explaining the newsletter stuff. Tom is an IT guy and is familiar with the tools we use in the newsletter and mailings. He went thru the whole process of creating the newsletter for Tom and highly recommends Tom to take over the Newsletter position.

He also commented on the Board loading up with Toms and the confusion that may cause. Neil then thanked the Board for their recognition of all the work he has done and the Flowers sent. It was very much appreciated by him and his wife.

GM, Teresa gave a short report with 1140 member renewed so far. The Lake Elmo post office is about 3-4 days back up on delivery.

New Members: Duane gave a report on the new member applications with over 175 received so far. He indicated talking with Charlie on planning the training for these new members and the Covid problem.

Patrick asked about the change in allowing people to join thru the year and how to handle it.

Charlie indicated the possibility of cutting off new members in July. Teresa also told of the problem of new members after July getting their service hours late in the year.

Club Opening dates. Tom indicated our opening to the public this year would be July 17 and follow the

same plan for open times we did last year. Question was asked about the open dates after MN deer opener. Teresa indicated the revenue would be based on the weather.

Amnesty for missed Service Hours: Tom Mader spoke with Neil about this. Neil indicated a number of members worked hard to complete their hours in spite of the Covid problem.

Neil did not want to just grant amnesty across the board. A list of members that reached out to Neil, Teresa, and Duane with COVID-19 issues was compiled by the secretary at the end of this season. Duane indicated he only granted amnesty to individuals that called and mentioned a problem with Covid exposure.

Tom Mader said his plan is to only grant amnesty to those that are on list Duane has.

## OGC January Board Meeting Minutes (Cont.)

Motion was made and seconded to only grant Amnesty based on Tom Mader's plan. All Board members present voted aye. The number of member loss each year is about 200 to 250.

There was a question if we follow up on the reasons members leave the club each year. Teresa indicated the members that have left in the past have been a member from one to several years so it is hard to determine why they left. Terry asked if we called the people that left to determine why they left.

Patrick indicated there have been many reasons why people have left. Terry wondered if there is something we could do to affect the number leaving. Tom wanted to go forward with the meeting.

Tom Schaeffer joined the meeting and was introduced to the Board as the new Newsletter Director.

Budgets: Tom M indicated it's critical to get the budgets in to Bill as soon as possible.

Security issues: Patrick indicated he would like to add cameras to the Short range and also the trap range. Also there needs to be updates to the electrical system. Cost would be less than \$15,000 for the security updates. Tom M indicated Patrick should submit his budget to Bill for approval.

Tom M wanted each Director to submit their budget to Bill as soon as possible. Bill indicated the spending for this year would be based on the 2020 budget of each Board member. If the Board member budget is more than allowed then it would be up to the Executive Committee to approve.

Drainage: Tom A, not present Herb indicated Tom turned over the survey to him. The preliminary survey Herb thought was about \$20,000 Tom M to follow up.

IT Problems: Patrick asked about how the IT issues are coming. Tom E indicated the Email for the Board should be done. Tom E also indicates he has been trying to contact the web guy with mixed results. He is trying to work through it. It seems to be normal with IT vendors that they are difficult to work with.

ADA Plan: Herb has a draft of items to be done. Estimate is \$30,000 to \$40,000 for work to be done. Time line is sometime in May. Daryll indicated he is looking for contractors to do everything and not member volunteers. Tom M wanted to be sure work is done by licensed and bonded contractors. Have had problems in the past with working with member volunteer work.

Should be a written contract with a timeline.

Trap: Report per Tom Mader, Daryll is not sure if the High School trap season will be as normal due to ammo shortage and covid. He indicated there is a shortage in ammo material like lead and copper that comes from China. Daryll has ordered several pallets of ammo for the High Schools to use. The ammo is coming from Italy and should be here in April. Bill has talked to Daryll about this purchase. Daryll needs to have participation by the High School trap teams in this program.

Secretary: Duane indicated his software is old and dates back to 2010. He would like to update his laptop and the software. Neil said to contact Tom E for these items as he has a plan for this.

Newsletter: Neil indicated Tom S should set a deadline of Jan 20 for input to the newsletter.

There is nothing else on the agenda so Tom M terminated the meeting. Tom indicated he will be phoning Board members later to follow up on discussions.

Motion to adjourn Meeting adjourned.

## Legislative Update

I would like to update the members about current legislative proposals in Minnesota. Since this is a new biennium, any previously proposed legislation must be re-introduced. During the previous session, no pro-gun legislation was introduced due to the political imbalance in the House of Representatives. Today the membership of the House is more friendly to gun owners, therefore making for a more favorable environment to introduce pro-gun legislation.

One of the more pressing issues is the process for renewing a Permit to Carry. By statute, the sheriff's office has 30 days to determine whether to grant or deny a permit to carry. Now during the pandemic, some county sheriffs are requiring an appointment to drop off an application. In the case of Hennepin County, available appointments to drop off an application are 3 to 4 months out. Many permit holders are finding their permits are expiring while waiting for their appointment. Both the House and Senate have introduced bills (HF-94; SF-25) to allow Non-In-Person Carry Renewal to eliminate this delay.

Stand Your Ground legislation has been introduced. This legislation clarifies the use of deadly force by removing the "Duty to Retreat" clause. Here is text from the revision:

### **Degree of force; retreat.**

**An individual taking defensive action pursuant to subdivision 2 may use all force and means, including deadly force, that the individual in good faith believes is required to succeed in defense. The individual may meet force with superior force when the individual's objective is defensive; the individual is not required to retreat; and the individual may continue defensive actions against an assailant until the danger has ended.**

Bills have also been introduced to eliminate the shotgun zone for deer hunting and to the Permit to Carry as equivalent to a firearms safety certificate for hunting in Minnesota.

Please contact your Minnesota state senator and representative to let them know you support Stand Your Ground and Non-In-Person Permit to Carry renewals. Go to <https://www.leg.mn.gov/> to identify your Senator and Representative. Also, visit <https://www.gunowners.mn/tracker> to keep informed about pro-gun and anti-gun legislation.

### WHAT IS THE POSTAL MATCH??

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / hers shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this;

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2021.

The events are:

- Handgun (Revolver) @ 10 Yards, open sights, timed fire.
- Handgun (Autoloader) @ 10 Yards, open sights, timed fire.
- Handgun (Rimfire) @ 10 Yards, open sights, timed fire.
- Handgun Unlimited 100 Yards, any caliber, any sight.
- Lever Action @ 100 Yards, scope, timed fire.
- Lever Action @ 100 Yards, iron sights, timed fire.
- Rimfire Rifle @ 100 Yards, scope, timed fire.
- Rimfire Rifle @ 50 Yards, open/iron sights, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, scope, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
- Varmint Rifle @ 200 Meters, scope, timed fire.
- Varmint Rifle @ 200 Meters iron sights, timed Fire
- Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.

Your official Postal Match Targets and specific event rules will be mailed to you within 10 days. You have all summer to complete your events using the honor system. When you have completed your events, return the score targets, by US mail, to Don Nelson at the above address by September 15, 2021.

The top shooter in each event will receive his/her \$5.00 Grand Prize and, of course, have bragging rights knowing he or she is "TOP GUN" in the OGC Postal Match. In addition, the top competitor in each of the twelve events will be recognized in the OGC Newsletter.

## Youth Director Update

Greetings members,

My name is Terry Derosier and I am the new Youth Director at the Oakdale Gun Club. I am in charge of scheduling the DNR Youth Firearms Safety Courses and the Youth Trap Shooting. Did you know that youth interest in shooting sports is on the increase? But, if you have kids, you may have experienced how hard it is to get into a DNR Youth Firearms Safety Course. It seems they are always filled up. I believe that "in-person training" is going to have a much deeper impact on a young person. It's so important for the youth to handle the guns and become comfortable with them. It's the passing on of tradition from one generation to the next. Youth Trap is also one of the fastest growing sports. Last year we had more than 305 youth and 16 volunteer coaches running the youth trap program. Incredible!! The legacy of the Oakdale Gun Club lives on through the youth thanks to the volunteers that so graciously give their time.

Youth today have many distractions and attractions to keep them locked to a smart phone or computer screen. I would like to work with our members to offer more shooting and training opportunities for the youth. But sadly, hunting is on the decline. How can we turn the tide? Many of you have notable expertise in the shooting sports. I would love to see a full slate of classes and opportunities every month for our youth. For example; Intro to Duck Hunting; Turkey Calling; Sighting in your rifle; Youth Summer Trap league; the list goes on. It's critical to shooting and hunting success to develop the proper skills and techniques at a young age. With that in mind, I would like to invite those that are interested, to a OGC Youth Advisory Committee meeting. (Feb 23rd , 7p-8:30p classroom) This is an opportunity to discuss how we can provide more quality short courses to meet the needs of our families and youth.
