My father was a 5/6th grade teacher and I remember him teaching Minnesota history. This kindled a deep love for the history and natural resources of our state and for enjoying hunting, shooting and the great outdoors! I would like to pass this on to the next generation. I am new to the club and I am looking forward to making friends and serving our membership to build the youth program. Oh, and by the way I like to ride motorcycle too. :-)

## OGC February Board Meeting Minutes

### OGC Board Meeting February 10, 2021

Meeting opened at 7pm

Board members present were Tom Mader, Thomas Baker, Duane Wilhelm, Bill Gacki, Charlie Ames, Tom Acheson, Patrick McNeil, Dean Cody, Dave Duepner, Herb Owen, Gail Angone, Thomas Schaeffer, Daryll Olson, Terence Derosier, and GM Teresa Reiter. Absent was Tom Etzel.

**Clay Pigeon Pricing:** First item was discussion on pricing clay birds. Tom was concerned with our current price of birds due to price increase and cost of sales tax. Daryll explained the current cost for the last clay birds was \$17006.25 for the load. Divided by 24 Pallets, divided by 63 cases per pallet equals \$11.25 per case. Adding in sale tax equals \$12.05 per case. Daryll indicated we are losing \$76 per load Discussion followed about other cost such as shrinkage and breakage. A motion was made to increase the clay bird cost to \$13.00 per case. Everyone on the Board agreed to price the Birds at \$13 per case.

**GM report:** Teresa: reported working with Neil to determine the number of members for possible renewal was 1388, There have been 1230 renewals to date which means 158 did not renew or about 11 percent loss of members this year. Terry Derosier talked with some pervious members about why they did not renew. He indicated they felt they were not treated well by other members.

**Reducing paperwork:** Tom A, we don't need to make out the forms for the matches by the Match directors each year unless there are major changes. The Match directors have been filling out the forms each year for the same matches that have not changed. As Match Director, Tom Acheson made a recommendation that the Match Director will not continue filling out the forms unless there is a new Director or new matches. The President indicated Tom should go forward with the recommendation.

**Toilets:** Tom M, asked about moving forward with search for toilet improvements. As Tom M remembers there was talk about making improvements to the current toilets. Gail indicated there was a search for portable toilets but they still would need water and electric hook up and have to be pumped. Teresa indicated the instructors were embarrassed about having the women use out existing toilets especially in the wintertime at 10 below. There has been lots of discussion about this subject in the past with no action. Dean C spoke to the need for flush toilets with all the HS trap teams and everyone that use the range. We seem to always look at updating the toilets, but it gets put off for another year. Gail volunteered to form a committee to follow up on the prefab stuff. She has some info from previous years to start with. Gail, Tom B, Dean and Herb agreed to follow up on this project. Charlie indicated a big improvement now would be to put in Styrofoam seats on the toilets. There also needs to be an update to the heat in the toilets.



## OGC February Board Meeting Minutes (Cont.)

**RSO scheduling:** Tom B, looking at members and hours and found 21,700 hours needed for service hours. He indicated there was more manpower than hours for service. Other board members also indicated his numbers did not include the members not required to do hours and those doing other jobs not RSO service. Duane indicated there were about 140 people applying for membership in the club this year so far. Discussion followed on need for gate guards when the HS trap and others will be starting  
Next newsletter should have info to members on how to sign up for service.

**Shotgun shell price:** Daryll, had talked to the supplier on the cost of the shotgun shells. The Board indicated the cost to the HS for shotgun shells will be \$6.50 per box. After discussion the charge to members will also be \$6.50 per box. We will not be supplying members with shells. . Shells should be shot on the range. Members will be allowed a box of shells per token of trap shooting. For the public the price will be \$8.00 per box and they also will only be able to purchase 1 box of shells per token of trap shooting. Daryll indicated Joe Moreno has made a slide presentation on trap training. It has been approved for training by Daryll and Tom M. It will be sent to the Board also for their viewing. Also, a slide presentation on RSO training for the trap range has been started and Daryl hopes to complete this for use by April-May.

**Drainage actions:** Tom A. He has sent out a lot of info to the Board on the Drainage issues on the ranges. It has been an ongoing problem for many years, but nothing has been done. He has given out a  
A, B, or C options to correct this. Don't know what the cost will be as we need soil borings to determine. An estimate for the consultant and other work may be over \$19,000  
Terry D gave his experience with doing drainage on his properties and how he has done it. Discussion followed by other Board members.  
Terry D and Tom A to get back to the Board at the March meeting.

**Budgets:** All big projects over and above the normal budget go to Herb.  
There will be a Special Budget meeting on Wednesday Feb 17 by all Board members needing a budget for their projects.

## Legislative Update

The first Anti-Gun legislation for the session has been introduced in the MN House and Senate. Universal Background Checks (HF 694; SF 894) introduced in the house by Representative Pinto. This legislation is virtually identical to a bill introduced during the last session. The bill intends to at a minimum discourage sale or transfer between private parties. Currently as written the legislation scope is limited to pistols and semiautomatic military-style assault weapons, however, deeper in the text those terms are replaced by the broad term – Firearm. There are provisions for private sale, but not without engaging law enforcement to perform background checks. I expect a lot of changes before this will get anywhere in the Senate. More to come on this I am sure.

Additional Pro-Gun legislation has been introduced including Constitutional Carry, an Anti-Red Flag Act and one that would prohibit the closing of shooting ranges during a state of emergency.

I have not seen any bills get more than an initial reading in committees. I will be watching the session agendas in the coming weeks so I can report a more complete status.

I encourage all members to go to the Bill Tracker and Action Center of the Minnesota Gun Owner's Caucus website (<https://www.gunowners.mn/>). The Action Center has highlights key legislation and features a quick way to send your senator and representative an email showing your support or disapproval on pending legislation.

### WHAT IS THE POSTAL MATCH??

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / hers shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this;

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2021.

The events are:

- Handgun (Revolver) @ 10 Yards, open sights, timed fire.
- Handgun (Autoloader) @ 10 Yards, open sights, timed fire.
- Handgun (Rimfire) @ 10 Yards, open sights, timed fire.
- Handgun Unlimited 100 Yards, any caliber, any sight.
- Lever Action @ 100 Yards, scope, timed fire.
- Lever Action @ 100 Yards, iron sights, timed fire.
- Rimfire Rifle @ 100 Yards, scope, timed fire.
- Rimfire Rifle @ 50 Yards, open/iron sights, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, scope, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
- Varmint Rifle @ 200 Meters, scope, timed fire.
- Varmint Rifle @ 200 Meters iron sights, timed Fire
- Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.

Your official Postal Match Targets and specific event rules will be mailed to you within 10 days. You have all summer to complete your events using the honor system. When you have completed your events, return the score targets, by US mail, to Don Nelson at the above address by September 15, 2021.

The top shooter in each event will receive his/her \$5.00 Grand Prize and, of course, have bragging rights knowing he or she is "TOP GUN" in the OGC Postal Match. In addition, the top competitor in each of the twelve events will be recognized in the OGC Newsletter.

Following in his brother's footsteps, and with support from his parents and fellow Scouts, Mason organized a build date on Jan. 23, to assemble the tables and benches, they were delivered on Jan. 27.

According to the Eagle Scout fact sheet, in 2019 only 8% of all Scouts BSA earned the Eagle Scout rank. Mason has been an active Scout since his first Cub Scout Pack meeting while in the first grade, he will graduate from Stillwater High School this Spring.

Mason chose the OGC Trap Range as the beneficiary of his project due to his participation on the Stillwater Clay Target Team. With the guidance of Daryll Olson, Mason chose to build the sturdy tables since getting into and out of a picnic table can be a challenge for some. Materials for the green treated tables was donated by Mason's grandfather and OCG member Bruce Penning. The benches nest neatly under the tables for off season storage.



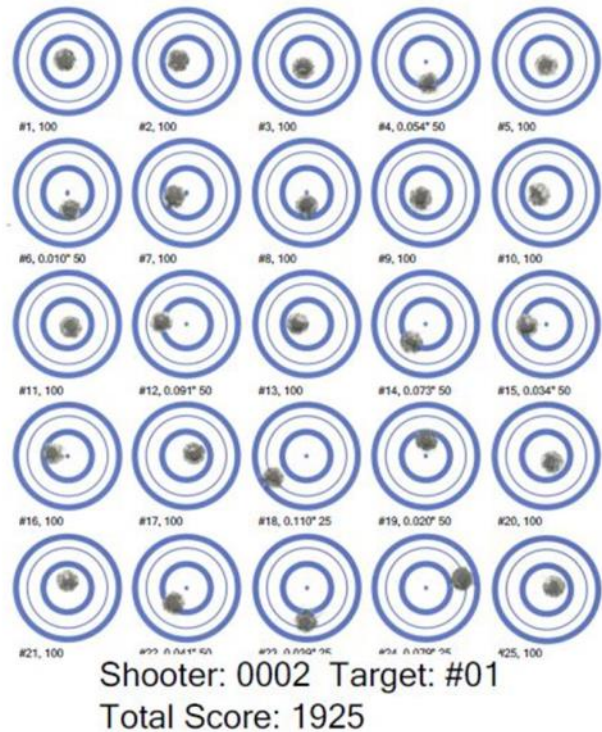
### Three Position Rifle Matches

These matches develop proficiency in firing for score in the sitting, kneeling and standing positions. Any repeating rifle, rim fire or center fire qualifies for use. There are no requirements or limitations to equipment. Any sight, any action, any modification is allowed. The challenge is for the shooter to excel in these positions which is typically not dependent on equipment at the amateur level. The match is comprised of 50 rounds at 50 yards; 10 rounds slow and rapid fire sitting, 10 rounds slow fire kneeling, and 10 rounds slow and rapid fire standing. Low velocity jacket or cast bullet reloads are suggested for reduced cost and recoil. Score your own targets. Brag to your friends and family and vow to do better next match. Because this is an "any gun" match, there are no competitive classes. Rotate between different guns during the season if you wish. Matches are the first and third Wednesdays, April through September. Open practice at 5:00, match starts about 6:00 and last about an hour. Match fee is \$5. For more info; Denis LaCroix, 651 488 - 2615

## Youth Director Update

### Youth FAS Training

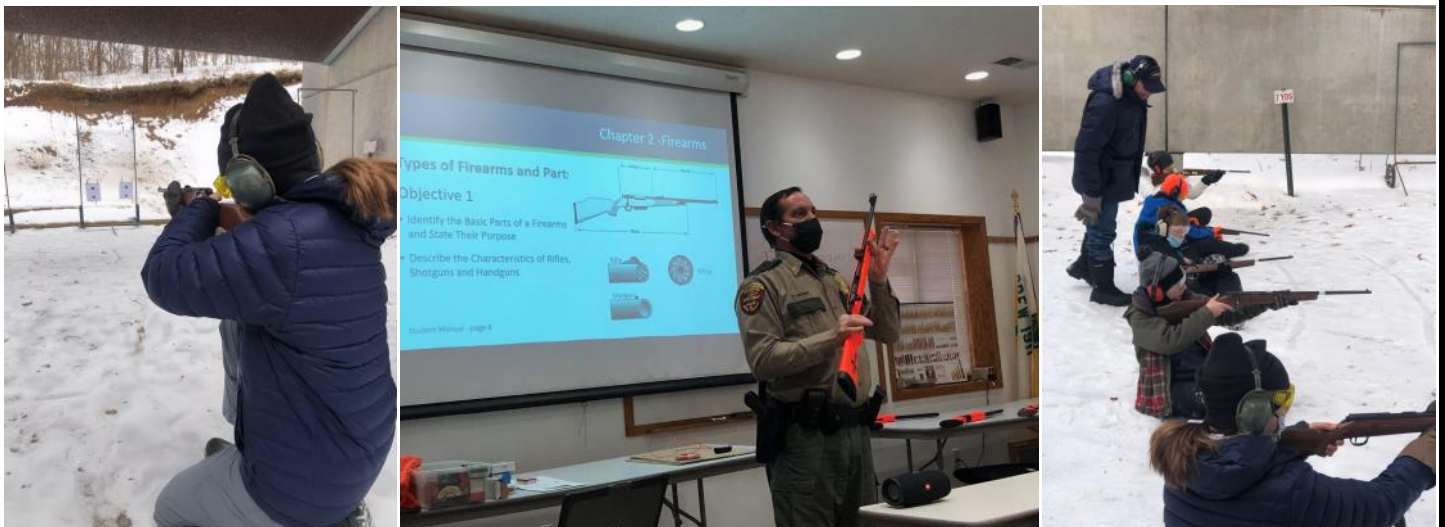
Tony Cadotte Firearms Safety Instructor along with assistant John Reginold hosted the first Youth Firearms training event in 2021 the week of Feb. 9<sup>th</sup>. Eight students participated. At that time, the state was limiting attendance to 10 participants. The students commented on how they enjoyed the hands on training. On Saturday morning for the field day, it was a frigid -10 below, so the shooting on the range went very quickly. Back in the training room students sipped hot coco as they discussed their new bragging rights!

### FASI Meeting

On February 18<sup>th</sup>, we had a meeting for Firearms Safety Instructors. 20 instructors, who were mostly new FAS instructors, discussed the calendar. Derosier introduced a new calendaring system of limiting FAS in-person classes to Tues, Thur, Tues, Thur, Sat. in order to try keep class dates more predictable. This was to allow for easier calendaring and to allow for doubling the amount of classes available. Lively discussion followed as ways to increase impact to students through mentoring, additional range time and survival skills around a campfire were considered. There are many instructors looking to work with an experienced FAS team leader.

### FASI Training

Firearms Safety Instructor training was held on February 21<sup>st</sup> and February 23<sup>rd</sup>. Approximately 25 new Firearms Safety Instructors were taught by Officer Philip George who is the regional training officer with the MN DNR for the Southeast Metro. The soon to be certified instructors were excited to work with either the regular classroom model or with the on-line field day model. Officer George used special training firearms to demonstrate how to operate the bolt and pass the firearm from one person to another. Derosier is trying to double the number of training dates for both the traditional method of FAS and also the Online Field Day method.

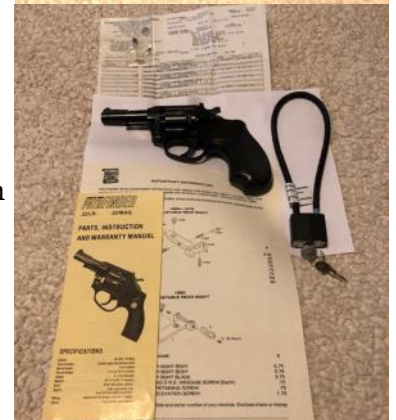
