Getting to know your OGC Board Members

I grew up in Northern Indiana hunting and fishing. Several of my relatives had farms so I enjoyed shooting and hunting there.

I started a course in Electrical Engineering at Purdue University in 1965. I was drafted in 1966 and ended up spending 2 years in Germany with the 7th battalion 16th Artillery with 8inch and 155 guns. After the Army I used the GI bill to attend Purdue University for Computer Science and received an Associate Degree in Computer Science and BA in Business. After getting a job at Whirlpool Corp in 1970 I moved with them to Minnesota in 1974.

I joined the club in 1979 primarily for a place to shoot 22 and shotgun. My basic arms in the service were the 1911 45acp, M79 grenade launcher and M14 rifle. I can't shoot an m79 at the club so I will have to just shoot the 45 and M14.

I became a certified Firearms Safety Instructor in 1982 and along with several members of our Instructor group looked at the 22 acres to the East, purchased by the club as a buffer, We worked to build the FAS field course, I used my Ice drill to dig the holes for the course signage. I have held the position of chief Instructor before becoming Secretary in 1986 after Jim Anderson resigned due to work requirements. I have continued to shoot at the club and teach FAS.

I also am a member of the Smith and Wesson Collectors group and the Heritage Arms Society and the Minnesota Weapons Collectors Association.

I have had the pleasure to see the club grow from a fish house when I joined to the Marah building and the classroom and all the additions to the ranges.

I will work to be sure the Club is here in the future

OGC June Board Meeting Minutes

OGC Board Meeting JUNE 9, 2021

Meeting opened at 7pm

For the first time in over a year the Board met in the classroom along with a Zoom meeting

Zoom Board members present were Dave Duepner, GM Teresa, Bill Gacki, Tom Acheson. Patrick McNeil joined late. Present in the Classroom were Tom Mader, Thomas Baker, Duane Wilhelm , Dean Cody, Thomas Schaeffer, Daryll Olson, Terence Derosier, Herb Owen, Charlie Ames, Gail Angone . absent was Tom Etzel. Meeting started at 7pm

The Pledge was said for the first time in over a year. Introduction of Board members present was made for the benefit of the New Members.

Bids for construction projections: Material prices are limiting recurring bids. Contractors are reluctant to give bids because of the rising material costs and problems with labor. Dean indicated his budget could possibly be 60k above the normal maintenance budget. Herb spoke on the ADA projects he estimates work costs at 29 to 30k. He estimates these cost could rise to 40k to do these projects. He put the Toilet projects on the screen for discussion. It was estimated to cost 89K and that did not include the well and septic which was another 40k. Tom consulted with the Treasure and Bill indicated we did not have to money to spend on this project this year. There may be alternatives to break up the project to do this in two phases. Tom asked Gail to get her crew together to put together alternatives in ten days. We still need a building on the trap storage building. Troy Dahlgren has just built a similar building we are purposing on his property and has given us an estimate on the cost. Daryl indicated the building size would be 36x63 and would require removal of several trees behind the house. Troy's estimate is \$64,000 with an addition of a floor and electrical bringing the cost to \$87,000. Troy suggested we could put the floor in next year. Per Bill G we could spend 105k for special projects this year. Bill also added we rarely overspend each year. He indicated there could be as much as \$130,000 for projects. One Director suggested the basement of the house could be used for the toilet facilities. Terry Derosier added that there are a lot of H.S students using the trap range and the basement of the house would work. There are several options for the location of the toilet.

There is a need for a trap building regardless of the need for the toilet. After lots of discussion about the toilets and the trap building Terry D. made a motion to build the trap building to include electrical for a cost of \$74,000 this year. Dave D. Seconded all Board members present voting aye. The flooring would be done next year.

OGC June Board Meeting Minutes (Cont.)

Liability Waver: Patrick not here so we will pass on the waver. Tom Acheson commented on the waver. We are missing indemnitee proportionality in the waver. He read a sentence that he added to every contract: <u>Where personal injury, death or loss of or damage</u> to property is the result of joint negligence, joint gross negligence or joint willful misconduct of Releaser and OAKDALE GUN CLUB, the indemnitor's duty of indemnification shall be proportion to its allocable share of such joint negligence, joint gross negligence or joint willful misconduct. Tom A will get with Patrick discuss this addition.

4H rental: Sent facility use form to Tom A. 4H did start yesterday on the range. Terry D indicated two of the 4H people not members were trained on gate guard. They have about 10 students and the leader and most of the coaches are members. Per Tom A with the number of students and number of coaches and leader members the students could shoot as guests of the members. Patrick indicated he did not get a response from the lawyers as yet.

Plastic curtain: Dean will be replacing 4 plastic curtains on ranges hopefully on the Committee on New Members: Need to have a fixed schedule of training for new members. Bald Eagle requires new members to have permit to purchase or CCP to join club. Discussed having new member submit a non-refundable fee when applying for membership. Dave indicated he would like to see a power point presentation for new members. Tom M indicated the committee should formulate a procedure for new member and present it to the Board next month.

H.S Trap tournament: East Ridge HS trap coach talked about having a trap tournament. The coach would like to use trap 1, 2 and 3 for the event. Tom M indicated he would not allow trap 1 to be shut down. Trap one should be available exclusively for the members. Motion made by Tom B to charge \$5 per round for the trap tournament and have them use trap 2 and 3 only. Second Majority aye.

Lead Reclamation: Tom B expressed concern about lead reclamation on our ranges. His thought would be the have the main companies submit a bid for reclamation on our range. Discussion followed on this procedure.

Concern was expressed on degrading the range berm in the process. Tom M added he needed more details before any decision will be made.

Teresa was on the zoom meeting and indicated her healing was going well. Herb ADA contract work: Motion made to have Troy Dahlgren do the ADA work for the club for cost plus. Seconded, majority voting aye.

Motion to adjourn Meeting adjourned. 8:25PM. Duane Wilhelm, Secretary, OGC

May 2021 Range Excavation Work Summary

The range excavating work has been completed.

These overviews are listed in the order of their priority, as the work was conducted.

Phase 1

50-yard Range #1 priority

A large percentage of the range floor between the firing line and target area, sees ankle deep water accumulating after heavy rains. This water needs to be "coached" to move to a low level off the range floor.

A shallow swale or trench has been cut the length of the range floor, from the firing line to the target area, on the east edge of the range floor. It slopes slightly downward from the south to the north. Water may

not percolate through the soil in the water accumulation area, but it should not be pooling up on the main range floor surface.



The bullet impact area has been reshaped. We are leaving the randomly dispersed tires on the surface as they are and we must avoid people walking on the area (to remove the tires) which would disturb the surface, contributing to erratic erosion. Foot and shoe depressions disturb the sloping bullet impact surface, maybe more than rain water run-off.

100-yard Range #2 priority

Water flows down the bullet impact area, across the target stand bases (covering them) and out on to the area range floor area in front of the target frames. This run-off water carries dirt with it and deposits mud in "all the wrong places". At times this water and mud can get "over the shoe" deep, making access to the target stands and chicken wire a real nuisance.

This range received quite a bit of attention, driven by

the fact that it is the widest bullet impact area that we have. The bullet impact area was resurfaced and much dirt was moved around between the base of the bullet impact area and rear edge of the line or plane formed by the target frames.





May 2021 Range Excavation Work Summary (Cont.)

100-yard Range #2 priority (cont.)

Out in front of the target frames, a west to east trench was dug, one on each half of the range, the width of the bucket on the machine. When doing this we discovered sand. This could be the red clastic glacial sand that the U of M geology department told us underlies much of our property (and much of the Lake Elmo area).

This trench was filled with coarse rock (clear rock, crushed and screened to $\frac{3}{4}$ "). 64-tons of rock was used for the project! We want accumulated rain water



to permeate into the coarse rock and then down into the sand underneath it.

200-meter Range #3 priority

Dirt washes down over the (3) stacked rail ties that support the steel target frames. This dirt becomes a wet, slippery mess in the area just south and out in front of the target frames. Water and dirt flow downward and south from the bullet impact area, accumulates there and needs to be redirected to a more suitable collection area.



Most of the work took place in the bullet impact area down at the far end. A "maintenance road" was cut to the right of and parallel to the east berm wall. This turned to the west and went into the base of the bullet impact area. The bullet impact area was resurfaced and then a shallow trench was cut sloping downward from the west side to the east side. Water runoff will then flow from west to east at the base of the bullet impact "wall". This trench extends to the east of the berm wall and then downhill and directs water to the low open

area to the east of the 200-meter wooden berm wall. This low area is roughly directly east of the 150-meter silhouette berm, north of the 25-yard range.

An additional benefit to the club regarding the new maintenance road....this is also there so that the club has future access to the area with machinery to do maintenance behind the steel target framework.

May 2021 Range Excavation Work Summary (Cont.)

Lower level south parking lot #4 priority

No work was done here The allowed hours spent for the work on the ranges used up the maximum overall cost. This was a low priority item. The south edge of the lot needs to be high and the north edge lower. We want to coach water to move south to north and west to east, being directed into the existing grade level grate drain. But...that drain line may need to be purged clean. We believe this drain terminates in the same area as the newer 200-meter drain line, under the Short Range walkway.

Over the next year we'll see how these efforts have improved our ability to more effectively redirect snow melt and rain water run-off. We now need to get to work on seeding the newly exposed surfaces. This improves the look and helps reduce erosion.

A special thanks to John Richards for identifying the areas needing attention, finding the excavation crew, Krueger Excavating, and spending a day of vacation time to coach the workers through the needed work.

Phase 2

Competition Range

The Comp range was not addressed in Phase 1. But down the road, it needs attention. Rain water and snow melt run down the slope adjacent to the steps, headed north, from the upper lot to the lower positioned range cover. Additionally, water runs off the south side of the firing line cover roof. Both of these water sources accumulate together in the gravel area behind the firing line and the firing line itself. And problems are compounded in cold weather when this mini-lake freezes. Walking across this and standing on it can be risky, to say the least.

We might want to dig a "test hole" to see how far down sand is. Quite possibly we could run into sand. If so, maybe install a reinforced round structure of sorts filled with coarse rock and install a grade level grating. Then we would see water running down into the grated opening, migrating through the rocks and sand and making its way into the aquifer. This is not industrial waste water or agricultural contaminated water, just typical runoff water. If this occurs naturally in much of the area's land and acreage, it can be allowed to occur in our small run off collection areas.

There is a grade level grating out on the range floor, on the east side before you come to the 25yard target frames. That unit drains into a 6" pvc pipe that terminates on the face of the 100-yard berm wall. Water departs that pipe and flows onto the 100-yard range floor. Not sure why it was thought to transfer water from one range to another but we did. We should add a couple of pvc 90 degree elbows and a section of straight pipe. The elbows would connect with the discharge opening of the existing stub in the berm wall and then the straight pipe connects to the elbows and slope downwards, running north to terminate and discharge directly near the area where the new trench with coarse rock fill is located. This would direct Comp range water to be purposely re-directed into a better area than it now is.

Range Duty

Range duty requirements

Service Hours

All Regular and Senior members are required to support the club operations by completing a minimum of **18**

service hours each year. Associate Members are required to complete 9 service hours. Members may choose range duty, grounds maintenance, work parties, competition matches and other miscellaneous club events throughout the year to fulfill the service hour requirements after their first year of membership.

New members (First Year) are required to work two Nine Hour days as Range Safety Officers to fulfill the 18 hours of service.

Exemption from Service Hours

• Rule of 75: Combination of your age plus years as a member (minimum of 5 years of membership)

equals or is greater than 75.

- Honorary Member: If you are age 65 or older and have 10 years of membership.
- Members who have twenty or more years may choose to be exempt from service hours but still pay

dues.

• Members on active duty are exempt from service hours

Exemption from Service Hours

• **MEDICAL:** Members with limiting medical conditions may request a medical exemption from service

hours for the current year. Medical requests must be submitted in writing with documentation supporting the claimed medical condition to the Secretary. Limited volunteer work is available for members with physical limitations. Medical exemptions are granted on a one-year basis.

Service Hour Tracking

Members are required to log their service hours on the Service Hour form. Members must complete the date, badge number, last and first name, work description along with start and end time on the form. The General Manager, Event coordinator or Board of Directors must approve the service hours.

Guest Requirements

Member Guest Requirements

Family Members, Guests and Pets

You are the Range Safety Officer for your guests and Family and are not allowed to be shooting at the same time as they are.

Members of your immediate family consisting of your spouse, partner and children may use the club facilities with you. All family members and guests must sign a waiver every time they use the club with you, unless they filled out an annual online waiver from our website. Although, there is no limit to how many immediate family members you bring, you must supervise your family at all times and they must be physically on the same range as you, arrive and leave with you. During "member only" hours, there is no minimum age limit for a shooter (during public hours, all children under 18 years old must show proof of attending DNR FAS). Children must be well behaved and under control at all times. All children must be directly supervised one on one while shooting. Anyone not shooting or directly supervising, must stay behind the yellow line. All family members must wear hearing and eye protection while on the range. Reminder: You are your family's RSO and are not allowed to be shooting at the same time they are.

During "member-only" hours, you may bring a maximum of three non-family guests at a time. You must supervise your guests at all times and they must be physically on the same range as you, arrive and leave with you. All guests must wear hearing and eye protection while on the range. **Reminder:** You are your guest RSO and not allowed to be shooting at the same time as the guests.

During open to the public hours, your direct Family (spouse, partner and children) may shoot for free on all ranges, BUT must give up their shooting lane immediately if needed for the paying public. This includes both the member and their family. While open to the public, the scheduled RSO's will be controlling the firing line, therefore the member may be shooting at the same time as their family. A member's guests (non-immediate family members) must pay to shoot on ranges open to the public. However, the guest may shoot for free on a member only range. You must supervise your family and guests at all times and they must be physically on the same range as you, arrive and leave with you.

Pets on the club grounds need to be on a leash or under direct control of the owner at all times. Pets left in vehicles must have water and proper ventilation. Pets are not allowed on the firing line. Pets are allowed in the range house provided they are clean, well behaved and quiet. The twenty-acre buffer area to the east of the range house may be used for exercise and training. Pets cannot stray onto the ranges or adjacent property. Owners must clean up after pets. The authorities will be contacted for any abusive or neglectful treatment of animals.
