### WHAT IS THE POSTAL MATCH??

### **POSTAL MATCH**

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / hers shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this;

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2022.

The events are:

- $\Rightarrow$  Handgun (Revolver) @ 10 Yards, open sights, timed fire.
- $\Rightarrow$  Handgun (Autoloader) @ 10 Yards, open sights, timed fire.
- $\Rightarrow$  Handgun (Rimfire) @ 10 Yards, open sights, timed fire.
- ⇒ Handgun Unlimited 100 Yards, any caliber, any sight.
- $\Rightarrow$  Lever Action @ 100 Yards, scope, timed fire.
- $\Rightarrow$  Lever Action @ 100 Yards, iron sights, timed fire.
- $\Rightarrow$  Rimfire Rifle @ 100 Yards, scope, timed fire.
- $\Rightarrow$  Rimfire Rifle @ 50 Yards, open/iron sights, timed fire.
- ⇒ Hunting Rifle (.270 Min Cal) @ 100 Yards, scope, timed fire.
- ⇒ Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
- ⇒ Varmint Rifle @ 200 Meters, scope, timed fire.
- $\Rightarrow$  Varmint Rifle (a) 200 Meters iron sights, timed Fire
- $\Rightarrow$  Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.
