Friendly Reminder on Public Hours

Members and their families are more than welcome to come and shoot on the ranges that are open to the public (25yd/50yd/100yd & 200m) but must abide by all "open to the public" rule changes.

A few we are having trouble with:

Unlike "member only hours"

- Everyone under the age of 18 yrs. must show proof they have completed DNR FAS.
- Only 1 shooting station allowed per person.
- Targets: one paper bullseye target per person per shooting station. You may use multiple bullseyes on one target.
- All shooting must be done sitting or standing. No shooting prone or kneeling positions.
- Only 1 uncased gun per shooting station allowed.
- No practicing drawing from the holster
- Nonfamily members (guests) must pay.
- Members and their immediate family shoot for free but must immediately give up their shooting station if someone from the paying public is waiting.
- Must follow all commands from the RSO's on duty.

Notes from the President

September, 2022

The next membership meeting is Wednesday September 14th. Door prizes will be awarded.

The September meeting, as directed by the bylaws, is the initial discussion on proposed bylaw changes or additions. If you have any ideas as to improvements you wish to see in the structure of the Club, this is your chance to present them. Please review the procedural steps mandated by the bylaws for submission of amendments.

In the past several years there has been a lot of discussion on the requirement of all members to be a member of a gun rights organization. This requirement dates back to the formation of the Club in the late sixties where the only source for affordable liability insurance was through the NRA. They, at that time, required organizations to have 100% NRA membership to qualify for their liability coverage. Things have changed and so has the OGC by expanding that requirement to several local pro-shooting organizations. I fully expect several bylaws change proposals to be presented in this area.

The fall season brings public shooters to our facilities under the supervision of our trained range safety officers (RSO's). All of these volunteer members have been briefed on safety, emergency procedures and club policy. It is up to them to enforce and maintain the safety rules. In the course of maintaining a safe shooting environment, I ask that it be done in a respectful and tactful manner. Be mindful that you are representing the total membership while dealing with a human being that may unintentionally or absentmindedly break a safety procedure. Treat others as you would like to be treated if you were on the receiving end.

The annual meeting is scheduled for Saturday December 17th at the usual location: The Oak Marsh Golf Club. Watch for notifications in the coming newsletters.

OGC August Member Meeting Minutes

OGC Member Meeting August 10th, 2022

Meeting started at 7:00 PM by Pres. Tom Mader.
Pledge was said.

There were 20 members present.

Minutes: The minutes of the past Member and Board meetings were read and accepted.

Treasure report: Daryll gave the Treasure report. He reported the balances of club funds as of this date. Discussion followed. There was a covenant on our loan to maintain a specific balance. Daryll questioned the bank about this requirement, and it is not required and was removed. There is a policy of not publishing this info in the minutes and in the newsletter. Any member having questions should contact Daryll or attend the member meetings.

Lake Elmo Night Out: OGC had a table at the Lake Elmo Night out. It was very windy that night and even though a lot of new member forms were handed out. Several women had questions.

Washington Co Fair: Joel Charchenko: 13 volunteers manned the Booth this year covering all 5 days of the Fair. Several volunteers have returned each year so training the volunteers is not a problem. Lots of people stopped by with questions.

Annual Picnic: 73 members attended this year with 64 adults and 9 children. Members paid \$9.00 to attend and additional \$444.00 was spent by Oakdale for food. Also, \$178 was spent for water, chips and misc. and \$329 spent for prize money. Total cost to the club was \$951.

Membership requirements: currently there is a requirement for membership in the club of either NRA or Mn Gun Owners Caucus or Gun Owners of America. The NRA requirement for membership in NRA was added years ago as NRA required this for the Liability insurance for the gun club. The two other groups were added later for member preference other than NRA. NRA no longer has our Liability insurance. NRA use to give us money from the membership fee of members who joined thru us. We no longer collect NRA membership fees and their membership program no longer returns money to clubs. There have been questions by potential new members to join the club without membership in the other organizations. This would require a bylaw change to delete this requirement. Any changes to the bylaws must be submitted next meeting (September).

H.S. Trap prices: discussion followed on prices to charge for trap next year. Recent increases in the Bird prices caused us to review current prices. After discussion, a Motion was made for trap for the High School at \$5.00, all members present voting aye. May re-examine next year if prices increase.

Drawing: voted to have two drawings of \$10 each. Winners were #19 William Vos, And #8 Teresa.

Trap building Policy on use: Daryll and Dean: Will be creating policy in writing for storage of stuff in the new Trap Building and will deliver it next month. Dean will have a work party this Saturday and sort out stuff and then be able to decide where to store our stuff. This is for now and future stuff in buildings.

Gift certificate Proposal: Teresa: Looking at options that will work on our POS system. Had a system on the old POS system but was very limiting. Trying to determine what will work on the new POS system and give us more options. Will have a proposal for next month.

Expenditures: Tom M. We do have some money for use this year. Tom wants to have any one wanting to address items at the member meeting or Board meeting to give information in advance. The items will be placed on the agenda for the meeting. This will give the Board a chance to research the items before the meeting.

There must be enough copies of the 2 items above for each board member. If there is more than one request for proposed changes to the Bylaws, they will be addressed collectively according to the above schedule. Detailed member discussion will not take place at the September meeting but will begin at the October general membership meeting. At no other time of the year will regular or board of directors meeting time be allocated for the purpose of discussing proposed changes to the Bylaws.

Thanks to the GREAT coaching and individual talents, all had safe and impressive seasons.

East Ridge High School

East Ridge High School Raptors Shooting Sports Team had a very successful Spring Season. Our Trap Team were Conference Champions with our male shooters finishing 1st, 2nd, & 3rd and our females shooters finishing in 2nd & 3rd in the Conference. We had 2 shooters in the Top 100 of the state, with our top finisher placing 2nd- Smashing 244 clays out of 250 for the season.

In post season, our Trap team finished 3rd at the State Championship. Our top 5 shooters shot 476 clays out of 500. We had one novice female shooter finish 3rd and 12 other shooters finish in the top 30 of their division. Our Sporting Clays team finished 4th at the State Tournament, just 3 clays out of 2nd place. We sent 7 shooters to Nationals. The competition was amazing. One of our shooters made it to the final round, shooting 193 out of 200 Clays. Missing only 7 put him in 119th place out of 1716 shooters.

A fantastic year for the Raptors. With most of our top shooters returning next year, we are looking forward to another great season.

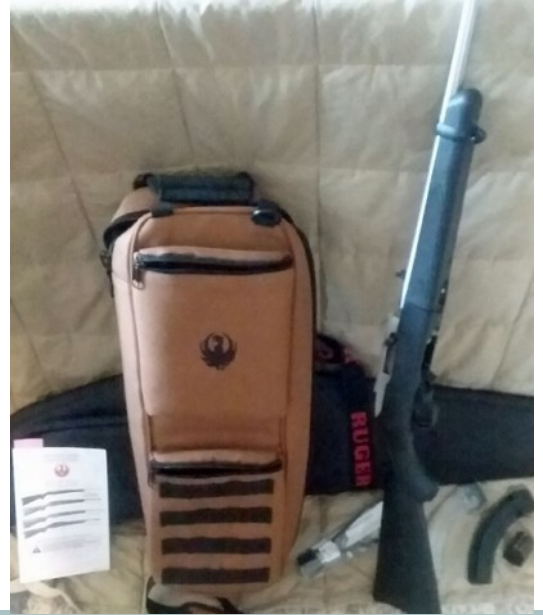
