OGC September Member Meeting Minutes

OGC Member Meeting Sept 13, 2023

Meeting started at 7:00 PM by President Gail Angone.
There were 35 members present.
Pledge was said.

Minutes: Motion made to approve August minutes as published in the Newsletter, Second, All voting Aye.

Finance: Gale gave the report of the club finances.

Bylaw changes: Byron asked for any changes to the Bylaws for this year.

Byron presented his Bylaw changes which will be published in the October newsletter.

Member Austin Harris presented his Bylaw changes which will be published in the October Newsletter.

Practical Pistol Report: Joe Griffin gave the report on the Practical Pistol Thursday night stats for this season. They are as follows:

Held 13 matches with 2 rain outs. 781 individual match entries for the season.

Of the 781, 331 were OGC members (43% of entries). Average match entries per match 60.

Average OGC members per match 25. Average round count per match per shooter 87. Average minimum shots fired per match 5,220.

Minimum rounds fired for the season 67,000. Total net income to OGC \$7,538.00

Kudos from Dean Cody to Joe, he runs a really good show.

Grants: Dan, we were awarded a grant from Midway USA for \$23,000 which will be matched by OGC to fund several projects. Projects include improvements to trap ranges, parking lots, equipment for NRL22 shoots and FAS equipment and others. The original quote was \$26,000. Midway USA gives out millions in grants each year to shooting ranges of non-profit status. There was a question about when the grant work will be done and trap range use but it can work around the Shooting on trap range. Gail spoke to the fact we are required to match the grant Funds. She also spoke to the work required to submit the grant. This grant can be applied for each year. Teresa spoke to the need to spend money for the NRL22 when Tom Baker talked about a donation of \$8000 to support the NRL22 program. Will be talking with Tom.

Security Update: Jack spoke to the update by Lloyds to our access controllers due to obsolesce. Worked last Tuesday to implement all the changes. Upgrade is a great improvement in ability to make changes and also option to do things remotely. This solves a lot of problems he had with the old system. He can also see activity at the club for all doors and close gate at night. Changes can be made easily compared to the old system. Still working on all the features. Provider of this support is Alarm.com, a large company. Kudos to Jack for his hard work.

Member raffle: Shanna, winner of \$10 are #6 Eric Osten and #19 Dean Cody.

OGC September Board Meeting Minutes

OGC Board Meeting
Sept 13, 2023

Meeting started at 8:03 PM by President Gail Angone
There were 11 Board members, the GM and 2 members present.

Member David Jameson appeared before Board to ask consent to set up training class. Wanted exemption for holding class. Would have class on weekdays and hold shoots on weekends. Would be for clay target training for adults. Would be contacting all coaches of schools shooting trap at Oakdale. Goal is to help parents of children that shoot trap to understand the game. There would be a charge for the class and some revenue to the club. Guns could be borrowed for trap shooting. He has more than one certified instructor for the class. Joel spoke to the fact we have novice trap on Wednesday night that would do that also. Joel was against the class. Discussion followed.

Motion made by Byron to allow David Jameson to hold trap class with class on weekday with normal classroom fee and trap shoot on weekend with trap fee. Motion was seconded with majority voting Aye.

Board members request for removal of Board member Jon Wood as Legislative Director due to nonperformance of legislative duties. His respond was in previous meetings he talked about legislative changes and had proposed informing members of the changes and had been shot down. He wanted the club to take a stand on the changes. Gail indicated when Jon came on board that the position of the club was to not take a stand on the issues only to inform the members of what was happening. Jon questioned the Bylaws and the Board asking for expulsion of him. Byron corrected him that the Board was only asking him to resign from the Legislative position. He would not resign.

Lead recovery: Herb gave a report on his check of possible lead recovery from the range. He checked with 2 companies. Shot is easier to reclaim than Bullets as they require more processing to remove the copper jacket. He checked the comp, 100 and 200 but did not find many bullets as it may require greater digging out the berm. Herb indicated one company could create a range lead management plan that could help schedule times to reclaim the lead. Both companies will be submitting a proposal. Not sure at this time if this would be a break even or money making revenue. Should have more info by next meeting.

Revenue issues: Gail spoke to looking at revenue issues. We are down from last year. Teresa spoke about lost revenue on the 100yd range due to NRI22 use of range. First customers on Saturday wanted 100yd but it was not available and they left disappointed. Can't compare this year to last year because of this.

There is a problem with revenue this year. The load of Birds also lowered the cash on hand. Gail changed the liability insurance Bill. We have aging membership which lowers the revenue from members. We need to do better promotional venues to get more members in the club. Discussed using coupons to increase Shooters. Joe's Sporting Goods will also have a promotion for gun sold with coupon to Oakdale on Sept 22. Idea is coupon will bring one person with hopefully their friends to the club. Possible ideas would be to increase the membership fee, have small group that pays high membership fee with no service hours or increase range fees.

Expulsion: Jon wood asked about the expulsion letter of his membership. Byron referred to Article 8 D in the by-laws. After debate on the issue, it was dropped.

Credit Card: Teresa: asked the Board for approval to add a fee of \$5 for credit card use in membership renewal.

Motion was made to add \$5 fee for use of credit card when renewing membership.
Second, majority of Board voting Aye.

Member indicated state grants are available for business open to the public.

Meeting adjourned at 9:20 PM.

Proposed Bylaw Changes

2023 Proposed Bylaw Revisions

Below are the Board of Director Recommendations or non-recommendations on the proposed changes to the bylaws submitted by members at the September 13, 2023 member meeting.

- These proposed changes, and/or amendments to them, will be discussed at the October and November 2023 general membership meetings.
- The Board of Directors shall vote at the November 2023 Board meeting to recommend or not recommend the proposed bylaw changes, the results of which will be posted in the December 2023 newsletter in preparation for membership approvals at the annual meeting.

<p>Proposed change by Byron Patterson</p> <p>Article VI: Officers, Board of Directors, Executive Committee and Employees</p> <p>A person must have been a member of Oakdale Gun Club for one consecutive year in order to be eligible to be elected to a position on the Board of Directors. A member who has been voted off the Board of Directors through the Expulsion and Suspension Process as provided for in Article VIII shall not be eligible to be elected to the Board of Directors again until a minimum of five consecutive years of membership has passed. All officers and directors of the club, except the immediate past president, must be elected by a majority vote by secret ballot of the eligible voting members at the annual meeting of the club as specified in Article V (C) of these Bylaws.</p>	<p>The Board of Directors recommends this proposed addition to Article VI.</p> <p>Needs further explanation from member of where addition should be placed under Article VI.</p> <p>Discussion required at the October 11, 2023 member meeting.</p>
<p>Proposed change by Austin Harris Change 1: ADDITIONS.</p> <p>Article V: Meetings</p> <p>G: Live Broadcast of Club Meetings and Remote Participation: All meetings for which the general membership may attend shall be broadcast live via freely available and secure collaboration software (IE: Microsoft Teams, Zoom). Opportunities must be made available for members to virtually attend and participate in voting. Members attending virtually may be asked to prove membership via display of badge, member number, email address of record with the club, or other means.</p>	<p>The Board of Directors does not recommend the use of live broadcasts or remote participation without further investigation.</p> <p>The use of live broadcasts using Zoom or other software should be tested for a few months at member meetings. A survey should then be done to determine if members find it useful, are they able to hear and follow member discussions.</p>

Proposed Bylaw Changes

Change 2: ADDITIONS.

H: Audiovisual Recording of Club Meetings: All official meetings of the club, including but not limited to Member, Board, and Executive Committee meetings shall be video and audio recorded and made available for viewing through the member portal.

The recording methods shall be:

Camera(s) covering the board member table(s) and the member seating area(s).

Microphone(s) for the board table(s) as well as room, table, podium, and/or handheld microphone(s) covering the general membership in attendance.

Screen Captures of any documents presented.

Scans of handheld documents.

An announcement must be made at the start of each meeting that anything following the announcement will be recorded. A sign must be conspicuously placed on the entrance to the meeting room to notify all members who join after the meeting has begun.

At the conclusion of the meeting, a vote must be taken to end the recording to ensure that all members in attendance have been able to address any topics they wish to discuss during the meeting. When no further topics are brought up for discussion, an announcement must be made to end the meeting.

These recordings shall be made freely available in video and audio format on the member portal of the club website. This task shall be assumed by the club secretary as part of their duties for recording the meeting minutes, with assistance from the IT Director.

A notification shall be published in the meeting newsletter as to where in the member portal the recordings are available. The direct link shall not be published to prevent unauthorized disclosure.

These recordings shall be considered sole property of the club and may not be distributed outside of the club membership.

These recordings shall be retained on the website for a period of no less than (2) years from the date of recording.

In the case of dissolution of the club all recordings shall be securely erased from the servers (6) months after the final meeting.

The Board of Directors does not recommend the Audio/visual Recording of Club meetings (change 2 below).

This request is not appropriate as an addition to the bylaws at this time.

This request would incur costs to the club and needs to be moved into Project status.

The project would need to provide the cost of such equipment and installation, a member polling to determine the number of members who would use it.

There are also privacy rights for members, the board of directors and the confidentiality of club business to be resolved.

After the project work is completed, it can be presented to the Board of Directors for a vote.

Proposed Bylaw Changes

<p>Change 3: CHANGES</p> <p>Article VI: Officers, Board of Directors, Executive Committee and Employees</p> <p>E. The Executive Committee of the Board of Directors consists of the president, vice-president, secretary, treasurer, chief instructor, chief match director and safety & security director.</p> <p>The Executive Committee of the Board of Directors has the authority to act for the Board in the areas of:</p> <ul style="list-style-type: none"> a) Administrative issues affecting the day to day functioning of the club that cannot wait for a board or member meeting. b) Financial matters totaling less than \$5000 unless pre-approved by a vote of members at a regular meeting or a special meeting with (15) day prior written notice provided to the general membership. c) Legal issues when under the guidance of a legal professional. d) Issues constituting an immediate safety and/or security risk to the club 	<p>The Board of Directors does not recommend the following proposed changes (change 3).</p> <p>The Board of Directors does not recommend the proposed changes to authority of the Executive Committee.</p> <p>b) Financial matters: The Executive Committee should maintain authority on financial matters less than \$5,000 to maintain the operations of the club. There may be incidences where equipment may need immediate repair or replacement, a service or vendor may be required, a safety/security or IT function may need to be addressed.</p> <p>Waiting for member votes or waiting 15 days for a special meeting would not be appropriate.</p> <p>c) Legal Issues: change proposed language to with guidance of legal professional when appropriate.</p>
<p>The authority of individual members of the Executive Committee to sign checks or perform other routine financial matters is outlined in Article VII, D of these Bylaws limited to projects of less than \$5000 in total unless pre-approved by a vote of members at a regular member meeting or a special meeting with (15) day prior written notice provided to the general membership. In accordance with the requirements of Minnesota law, the club secretary will keep minutes of the Executive Committee and maintain them with the official club records. Minutes, with the exception of privileged legal discussions, must be available to other board members and club members in accordance with the requirements of state law. The secretary shall recap actions taken by the Executive Committee at the immediately following board meeting. The Executive Committee may not hold meetings to vote on expulsion or disciplinary actions against other members except to issue temporary suspensions in cases of an immediate safety or security risk to the club per Article VIII Section F.</p>	<p>The Board of Directors does not recommend this proposed change in its current language as it needs further explanation by the member making the proposed change.</p> <p>Discussion required at the October 11, 2023 member meeting.</p>

Proposed Bylaw Changes

<p>Change 4: CHANGES Article VIII: Expulsion and Suspension A. Any officer or director can be removed from office by a vote of a two-thirds (2/3) majority of the eligible voting members present at a special member meeting called for the purpose of hearing arguments on the matter. No vote on removal from office may be taken unless at least fifteen (15) days written notice has been given to the officer or director all members stating the reasons for their proposed removal as well as the date, time, and location of the special meeting. The officer or director must be given a full hearing by the membership present at the meeting before a ballot regarding their removal is to be taken. A report of the results of such ballot must be presented to the general membership in the club newsletter. This meeting must be open to all members. Any officer or director removed from office by member vote may not be elected to nor hold an officer or director position as defined in Article VI Sec. B. for a period of no less than (5) years.</p>	<p>The Board of Directors does not have issue with this proposed change.</p> <p>Discussion required at the October 11, 2023 member meeting.</p>
<p>B. Senior, regular, honorary and associate All members may be suspended or expelled from the club for a cause deemed sufficient by a two-thirds (2/3) majority vote of the Board of Directors present at any regular or special board of directors meeting. No vote on suspension or expulsion may be taken unless at least fifteen (15) days written notice has been provided to the member all members detailing the charges brought and of the time and place of the meeting that such charges will be considered. The member being charged must be accorded a full hearing at such meeting. In cases where the action determined by the Board is suspension, the period of the suspension must be agreed upon by a two-thirds majority vote of the Board.</p>	<p>The Board of Directors does not recommend this proposed change in its current language.</p> <p>The board of directors suggest a change in the first sentence; All members should be changed to Any member.</p> <p>Discussion required at the October 11, 2023 member meeting.</p>
<p>C. Charges against any officer, director or member may be brought by any member in good standing. The charges must be in writing, clearly stating the relevant facts, and accompanied by any affidavits supporting the charges. The secretary shall provide at least fifteen (15) days' notice of the special hearing meeting to each member of the Board, the accused and the accuser all members. In the case of charges against an officer or director, the fifteen (15) days' notice of the special meeting must be made to the general membership as well. The notice must be in the club newsletter and include true copies of the charges and supporting affidavits or exhibits.</p>	<p>The Board of Directors does not have issue with this proposed change.</p>

Proposed Bylaw Changes

D. Any ~~senior, regular, honorary or associate~~ member suspended or expelled by action of the Board of Directors may appeal to the full membership of the club. Such appeal must be made in writing to the secretary, who will notify the president. The president shall call a special meeting of the club for the purpose of acting on the appeal. The secretary shall provide at least fifteen (15) days written notice to all club members in good standing stating the date, time, place, and reason for such special meeting. At the meeting, the secretary shall read the original charges, any supporting affidavits, and the minutes from the board of directors meeting at which the charges were heard and the action taken. A full hearing must be provided to the appealing member and the accuser, or a representative of the Board selected to present the board's arguments. A vote must be taken where the final decision concerning suspension or expulsion requires a majority of the eligible voting members present at the meeting.

The Board of Directors does not have issue with this proposed change.

~~E. Any officer, director or member of the club who has been suspended or expelled by the National Rifle Association of America is automatically suspended or expelled from the Oakdale Gun Club immediately upon receipt of official notice from the National Rifle Association.~~ Any member who brings an accusation against another member, officer, or director in good faith shall be protected against retaliation. No member, officer, or director who has been accused may be included in disciplinary vote against the accuser for a period of (1) year from date of the special meeting called to address the accusations. Any member, officer, or director found to be acting in retaliation shall be subject to disciplinary action per sections A, B, and C.

The statement in red text is recommended by the board of directors to be removed from the official bylaw document.

The Board of Directors does not recommend the proposed change in green text in its present language.

Recommendations from the Board of Directors for Article VIII: Expulsion and Suspension would be to add parameters to the process.

The burden of proof is on the accuser. Either use the Executive Committee or establish an Expulsion and Suspension Review Committee to investigate allegations and make a determination that there is merit to the accusation(s), the accuser has provided verified documented proof of what they allege did actually occur or not occur before any proceedings for expulsion or suspension can begin. Allegations/accusations cannot be based on hearsay, personal opinions or personal ill will against another member.

The proposed committee in #2 above should also make the determination concerning retaliation efforts.

Discussion required at the October 11, 2023 member meeting.

Proposed Bylaw Changes

F: Neither the executive committee nor any other special committees have the authority to hold any special expulsion or disciplinary meetings except to issue temporary suspensions pending a full meeting in cases of immediate safety and security issues to the club.

The Board of Directors does not recommend the proposed change in green text at this time.

Needs further explanation by the member submitting the change.

Discussion required at the October 11, 2023 member meeting.

Notes from the Member Special Meeting September 20, 2023

An Expulsion Special meeting was held at the club on September 20, 2023 at 6:30. A short presentation by Jon Wood, accuser of Duane Wilhelm and Gail Angone was presented as was a short presentation by Duane Wilhelm and Gail Angone.

A ballot vote was taken by attending members.
