Marketing Report: Was given by Ken Nelson. Was set up at National night out at Lake Elmo with Ken, Dick, Charlie and Gale. There was interest in joining the club but he had to tell him not right now. (Take in members from Jan – June each year. He talked to Joe's Bait and they are interested when they sell guns in having a \$10 discount coupon for shooting at the club. He would be working with the guy at Joe's for a date. Ken asked about advertising for the club and Gail responded we can't afford an advertising budget. Gail would like to advertise in the newsletter for a member with that experience to volunteer for the job. There was also discussion on having a social media presents for the club. A member stated it is not an issue advertising in social media.

Bylaw Committee: Byron gave an update on the committee currently doing changes to the Bylaws for membership categories and he/she changes and others. Goal is to get this done before September Board meeting.

## OGC Expulsion Request

Dear OGC Membership,

Per Article XIII, Section A of the Bylaws, I am writing to begin the expulsion process for Gail Angone, President of the Board of Directors/Executive Committee, and Duane Wilhelm, Secretary of the Board of Directors/Executive Committee, for breach of fiduciary duty. They did not adequately inform the membership, nor did they seek proper authorization for large capital expenses.

Duane Wilhelm served as Secretary and Executive Committee member in 2021 and 2022. During the same period, Gail Agnone served as Marketing & PR Director and was the project manager for the "Bathroom Project." Gail is currently the Club president. According to Article XII, Section B of the Bylaws requires,

***Any contract, purchase, rental, or other commitment which will require the expenditure of thirty-three (33)% or more of the sum of the checking account, plus cash, plus certificates of deposit or \$75,000, whichever is less, requires written notification of the club membership and approval of a two-thirds (2/3) majority of the eligible voting members present at a regular member meeting where there has been prior written notice in the newsletter that a discussion and vote on the subject will occur.***

During the 2021/2022 period, the "Bathroom Project" was improperly approved. The project exceeded either Bylaw expenditure guideline—the initial proposal from EFH Co, dated 04/12/2022, detailed preliminary project costs of **\$87,271.00**. A revised proposal from the same firm, sent on 08/12/2022, showed a significant increase of **14%** to **\$99,473.00** (Exhibit 1).

I suspect the total project costs exceeded \$99,473.00. Whatever the final amount, all or part of the amount was financed, so the long-term project costs will be carried over many years and will greatly exceed the proposed amount.

I have only received this one invoice detailing this two-year project. I have requested a detailed internal report from the Treasurer of all "bathroom project" related costs, including the bathroom, well, and garage addition. I have not received any further information on my request.

The Bylaw approval process required notification of all members. This notification would have also included notice of a regular member meeting where a discussion and vote would have occurred. This process did not happen. Furthermore, in a 08/05/2023 email, Gail Agnone explained,

***... let's get your facts straight. The restroom project started in 2021 and was a 2 year project. Invoices were split up to cover costs of what work was being done when. Invoices paid were under the \$75,000 thus not needed membership approval.***

## OGC Expulsion Request (Cont.)

Dividing the recognition of project costs over two years does not reduce the project costs to a level below the threshold proscribed in the Bylaws. This either shows a tremendous lack of understanding, or was a sneaky accounting gimmick used to circumvent the approval process. Either way, Gail and Duane violated the member's rights to provide input and approval on large capital expenses.

At the exact time project costs were greatly exceeding expectations, Gail, Duane, and others sought to change the Bylaws to include a special tax on the membership of \$50, which could be imposed at each monthly board meeting. Article IV, Section A1a of the 2022 proposed Bylaws detailed,


*The Board of Directors may institute a Special Assessment in the case of a financial requirement to the Club that is above and beyond the normal operation and necessary to maintain the quality operation. This Special assessment shall not exceed \$50 per occurrence.*

Rather than responsibly managing the finances of the Club, Gail, Duane, and others sought to impose a tax on the membership that, as written, could have meant an additional **\$600 per year, per member**. The changes to the Bylaws were defeated, yet their intentions were clear. Even changes, that are underway for 2024, have consistent themes that hide information and neuter the influence of the membership, and allow leadership to act independently.

Additionally, the 2022 treasurer's report at the annual meeting left many people worried about the OGC finances. As a board member in 2023, my experiences with finance reporting have been equally troublesome. Thankfully, we have a new Treasurer. I have requested that he provide immediate attention to a detailed accounting of the "bathroom Project."

In the meantime, I request that the expulsion process begin. I strongly encourage membership involvement, and I am open to your questions. I look forward to the membership's decision.

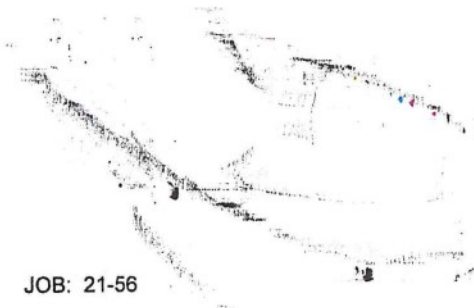

# OGC Presidents Response to Expulsion Request

## Response to Jon Wood's Accusation(s) against Gail Angone

The burden of proof is the responsibility of the accuser. Jon Wood has made serious allegations without providing any evidence to support his accusations. Not only are Jon Wood's accusations false, but misdirected. **I was not President at the time in question.**

### BACKGROUND INFORMATION:

1. As most members know, the need for the club to provide improved restroom facilities has been discussed and investigated for 10 years or more. Options from expanding the existing wooden 2 stall structure, to exploring portable restrooms on a trailer bed to converting an existing building on the club's grounds were considered.
2. The determining factor to move forward with ADA accessible restrooms began in 2020:
  - An ADA inspection was conducted in 2020 by Julee Quarve-Peterson of JQP, Inc., specializing in accessibility for The Americans with Disabilities Act of 1990. ADA Stands for Accessible Design and the Minnesota Building Code, Chapter 1341 Accessibility.
  - The report by JQP, Inc. listed ADA issues throughout the club that had to be addressed. This included the need for ADA accessible restrooms. Membership meeting minutes from Feb 12<sup>th</sup>, 2020.

**Accusation I:** Part 1: "Per Article XIII, Section A of the Bylaws, I am writing to begin the expulsion process for Gail Angone, President of the Board of Directors/Executive Committee, and Duane Wilhelm, Secretary of the Board of Directors/Executive Committee, for breach of fiduciary duty. They did not adequately inform the membership, nor did they seek proper authorization for large capital expenses." **FALSE** Part 2: "The Bylaw approval process required notification of all members. This notification would have also included notice of a regular member meeting where a discussion and vote would have occurred. This process did not happen." **FALSE**

### FACTS:

*Article XII: Authority of Board of Directors and Indemnification, B:*

*"Any contract, purchase, rental or other commitment which will require the expenditure of thirty three (33)% or more of the sum of the checking account, plus cash, plus certificates of deposit or \$75,000, whichever is less, requires written notification of the club membership and approval of a two-thirds (2/3) majority of the eligible voting members present at a regular member meeting where there has been prior written notice in the newsletter that a discussion and vote on the subject will occur."*

1. The Tom Mader, President at the time in question **did indeed properly call and announce** for a Special Meeting for blanket approval in excess of the bylaw set limit of \$75k to cover the total ADA requirements/improvement projects as posted in the March 2020 Newsletter.
2. The vote results for the blanket approval over \$75k **were indeed properly recorded** in the meeting minutes of the April 2020 Newsletter.
  - Excerpt from March 2020 Newsletter: "Because the planned expenditures will surpass the bylaw set limit of \$75K there will be a ratification vote by the membership at the March meeting. Since we do not have a good handle on the individual costs of each project, at this time, the vote will be a blanket approval vote to cover the total improvement budget".

## OGC Presidents Response to Expulsion Request (Cont.)

- Excerpt from March Meeting Minutes in the April 2020 Newsletter: *“After discussion, a motion was made and seconded for a blanket approval vote on the projects listed that will be addressed in the order above. The Majority of members voted Aye for blanket approval of the above projects with 1 member opposed”.*

**FACTS:** Tom Mader, President at the time in question performed fiduciary responsibility by obtaining the proper approvals for an expenditure over the \$75k limit.

**Accusation 2:** *“At the exact time project costs were greatly exceeding expectations, Gail, Duane, and others sought to change the Bylaws to include a special tax on the membership of \$50, which could be imposed at each monthly board meeting”.....*

**FACTS:**

1. No assessment fee proposal was ever submitted for membership approval. In fact, none of the proposed changes to the Bylaws were presented to membership for voting at the annual meeting in 2022.
2. No assessment fee proposal is in the 2023 proposed bylaw revision document.

**FACTS:**

*Article VII: Duties of Officers and Directors states:*

*“No single club officer or director or group of officers acting independently of the Board of Directors shall enter a contract without authorization by a majority vote of the Board of Directors.”*

**Accusations are misdirected:**

1. Tom Mader, President at the time in question had the responsibility to properly obtain authorization for expenditures over \$75k. Tom Mader fulfilled this responsibility.
2. **No single club officer or director can act independently of the Board of Directors.**

**IN CONCLUSION:**

- Did the President at the time in question properly call for a Special Meeting for approval in exceeding the bylaw set limit of \$75k. **YES.**
- Was membership notified of the special meeting. **YES.**
- Was the vote result properly documented in meeting minutes at the time in question. **YES.**
- Was the \$50 assessment fee established. **NO**

My written response and supporting documentation prove all allegations false.

### Attention Members

#### Major Project Summary 2020

The BOD has settled on range improvements for the 2020 construction season. Heavy emphasis was placed on ADA compliance projects and drainage issues. A summary of the projects is presented below for membership approval at the next membership meeting.

- ◆ ADA compliance projects generated by a certified consulting engineering firm on our facility.
- ◆ Total ppty drainage assessment by a hydrologist.
- ◆ Grading and back fill as required for drainage.
- ◆ New roof on 25 and possibly 50 yd range.
- ◆ Safety modifications to Trap house #1.
- ◆ Road and parking lot upgrades.

Because the planned expenditures will surpass the bylaw set limit of \$75K there will be a ratification vote by the membership at the March meeting. Since we do not have a good handle on the individual costs of each project, at this time, the vote will be a blanket approval vote to cover the total improvement budget.

#### RSO Scheduling

The range will open to the public on the first weekend after the Fourth of July. Scheduling of RSO dates will tentatively be on or about April first. Watch for more information in future newsletters.

### Note from the VP March 2020

Many changes have taken place in the past month. The past president has withdrawn for personal reasons, which places the vice-president into that position via the bylaws. This creates a vacancy in the position of VP, which must be filled by a selection of the BOD. If you wish to contribute to the Club in this capacity please contact the secretary at [sec@oakdalegunclub.org](mailto:sec@oakdalegunclub.org) prior to the March BOD meeting.

After consulting with two law firms the club has contracted an engineering firm specializing in ADA compliance law to evaluate our facility for conformance. That firm reviewed our total facility in early February and will do it again when the snow is gone. The BOD has committed \$50k of funds in 2020, to make our ranges compliant with ADA regulations. The Long-range Planning Director will be coordinating all activities in this regard and will maintain a communication link with the members.

Planning accomplishes no tangible improvements unless members come forward to oversee each project. If you are interested in assisting this club move forward and at the same time fulfilling your work requirement contact [VP@oakdalegunclub.org](mailto:VP@oakdalegunclub.org).

Needed are several volunteers to research drainage consultants, grading contractors and roofing contractors, among others.

Meeting opened at 7:00 PM by Vice Pres Tom Mader

Pledge was said.

Attendance at the meeting was 30.

At the start of the meeting the President explained there is a door prize based on the numbers on the sign in sheet.

**Secretary** read the minutes from the January member and Board meetings. A **Motion** was made and seconded to approve both minutes as read. All voting aye no opposed.

**Trap Director:** Prior to the member meeting a vote was taken by the Board to appoint Daryll Olson to the Trap Director position with a majority voting aye. Daryll came before the membership as the Board Appointed candidate for the new Trap Director position. Prior to the vote by the membership, as required by the Bylaws, he gave a brief bio of his qualifications. A vote was then taken with a majority voting aye for Daryl as Trap Director. Teresa indicated there is no formal definition on the trap position in the Bylaws. This will be addressed by the Board.

**President:** Bob Ries has tendered his resignation as president for personal reasons. Tom gave the procedure per the Bylaws for the Vice President to take over the President position. She mentioned the ramp to the club house and toilets need to be updated for ADA compliance. Teresa also spoke on the current idea of bringing in trailers for our Toilet requirements The ADA people cautioned us on the trailers as they may not meet Minnesota requirements. Teresa also talked on the parking requirements and indicated they may meet Wisconsin requirements but not Minnesota.

**Annual Picnic:** Tom discussed the picnic this year and what had happened. People did not like the food and that will change this year. Also maybe pick a different time for the picnic. The day last year had problems with daylight and was also small game opener so should hold it earlier in the year. A recommendation was made to move is back to the previous time.

**Clay Pigeon Pricing:** First item was discussion on pricing clay birds. Tom was concerned with our current price of birds due to price increase and cost of sales tax. Daryll explained the current cost for the last clay birds was \$17006.25 for the load. Divided by 24 Pallets, divided by 63 cases per pallet equals \$11.25 per case. Adding in sale tax equals \$12.05 per case. Daryll indicated we are losing \$76 per load Discussion followed about other cost such as shrinkage and breakage. A motion was made to increase the clay bird cost to \$13.00 per case. Everyone on the Board agreed to price the Birds at \$13 per case.

**GM report:** Teresa: reported working with Neil to determine the number of members for possible renewal was 1388, There have been 1230 renewals to date which means 158 did not renew or about 11 percent loss of members this year. Terry Derosier talked with some pervious members about why they did not renew. He indicated they felt they were not treated well by other members.

**Reducing paperwork:** Tom A, we don't need to make out the forms for the matches by the Match directors each year unless there are major changes. The Match directors have been filling out the forms each year for the same matches that have not changed. As Match Director, Tom Acheson made a recommendation that the Match Director will not continue filling out the forms unless there is a new Director or new matches. The President indicated Tom should go forward with the recommendation.

Soil erosion in the bullet impact area behind the normally positioned target is a big enough problem without adding to it with this unacceptable target placement practice.

## Previous Past President Response to Expulsion Request

### Statement from a Past President

August 28, 2023

I am Tom Mader and I was the previous president of our club for the past two years. Prior to that I was the VP for several years. I have been a member continuously for fifty-six years. Additionally, I was the second secretary of the club when we had a membership of thirty members. Over those past five decades I have witnessed the expansion of the organization from a fledgling shooting range to its present premiere full-service shooting facility located just nine miles from the state capitol.

This expansion to the present state was due to the unselfish dedication and extreme hard workings of many volunteers who devoted a considerable amount of their spare time to the hobby they loved. I have had the good fortune to have been able to know and work with scores of these unselfish individuals. Foremost among these volunteers are the few that chose to serve on the Board of Directors. The common thread binding every one of these volunteer directors is their personal goal of advancing the Oakdale Gun Club for the benefit of you and future shooting enthusiasts. I cannot overemphasize the enormous number of hours each board member devotes to the Club every month of the year.

In the past several weeks the cohesion in the present Board dissolved when a first-time board members brought unsubstantiated and false charges against the current president and secretary.
