Saturday, February 17 - 8:00 am to 12:00 noon

#### Frozen Chosin - 20th Anniversary

The Battle of Chosin Reservoir took place in 1950 late November to mid-December. The US Marine Corps and US Army are known for taking all of their wounded and dead out with them as they withdrew. Veterans of the battle are often called The Chosin Few. (17) CMH were awarded, second only to (20) CMH's awarded for the Battle of the Bulge in November 1944 during WWII.

The match is conducted in cold weather, usually February, replicating the weather conditions seen during the battle, and match shooters are encouraged to use rifles that were used by American forces during the battle. Many shooters use the M-1 Garand rifle with .30-06 ammunition and no scopes are used, just iron sights

Oakdale's effort is to commemorate the US Military's valiant efforts of that long ago battle. The first match was organized and ran by our Charley Ames, in 2004. So this is the 20th anniversary!

## OGC Member Meeting January 10, 2024

Meeting started at 7:00 PM by President Bob Lawrence

There were 20 members present.

Pledge was said.

President: Bob Lawrence introduced himself to the members.

**Secretary Report:** A Motion was made to accept the minutes from the November 2023 Member meeting were approved as printed in the newsletter. Seconded, with a majority members present voting aye. A motion was made to accept the minutes from the December Annual meeting as printed in the newsletter. Seconded, with majority members present voting aye.

### **New Business:**

**Insurance Audit, President:** Bob indicated in order for the employee dishonesty policy to renew there needs to be an internal financial audit of 2023. He had talked with the treasure. John indicated the biggest obstacle to overcome was getting the income in the right buckets. He indicated the insurance people would not be concerned with where exactly the income came from like trap or public shooting. They would be more interested in we made x amount of money and spent x amount of money which is information he has. Bob asked if within a week or so something could be put together to send to the Insurance company. John is working on it and should be able to get it done.

**Treasurer report, John Geisler:** John is currently setting up OGC accounting. We now have our own QuickBooks. He is also trying to sort out and get access to the credit card information as the information is currently locked. He has applied for new cards for use by Dean Cody and Teresa so when items are needed the club card would be used and not have members purchase items and create more paperwork. He is still locked out of several areas and trying to get access to the passwords and logins etc. Bill Gacki did a great job in the Treasure position and we will miss the organization he had. The hand off of accounting never happened like in the past so John has spent several hours making sure all Accounts Payable, membership and categories are in our QuickBooks according to common account practice. Motion made to accept John's report by Bob Kamholz with second by Dean Pelnar. Majority members present voting aye.

**Vice President report, Austin Harris:** Not much happening at this time. Still working on Sign up Genius. When set up for opening to the public then he will get sign up Genius ready for work hours. Question Dean Cody when is date to open to public? Austin answer is waiting until next month to set date when membership numbers and Treasure etc. set up. Teresa reminded him to be sure new member orientation is advised they will not be able to sign up for work hours yet.

### **Old Business:**

Bob stated he will have New Business but items will stay in Old business until resolved.

**Revenue Committee, Bob Lawrence:** There was a meeting last Wednesday. He asked Eric Osten if he wanted to comment but Eric deferred to Dan Jamison to report. Dan was absent so Bob gave a report for Dan. There is a long list of ideas for revenue. Over 35 that are being prioritized. He is gathering a list of information. We will need to think and act differently. We will also need to have active participation by members. This includes reviewing and potentially revising new policies for revenue. Committee work is ongoing and Dan expects to bring things forward to February meeting for more discussion and potential action execution.

**Auto fire on Range, Duane:** Two long standing member requesting authorization to do auto fire on the Comp range. This is a yearly request and the two members have asked for it for several years. It is noted that they don't do this often as ammo cost is a huge factor. There were several questions from members. Reminder that members are required to appear in person for the permission.

This action was tabled until next month.

**Bylaw Policy and Grants, Austin:** Previous years bylaws were looked at through committees but missed the September deadline. He is planning to start Bylaws Committee. Committee member volunteers will be chosen this month that will be official at the February meeting. That committee will go through July and at that time the Bylaw changes will be finalized and recorded in August and submitted in September. Also at the February meeting a policy committee will be named to check the policies that are outdated or poorly written. Those changes will be rolling to make changes as needed and follow the same time period as the Bylaw committee. Eric Osten commented the changes for both Bylaw and Policy have multiple issues so both committees should coordinate their changes. Finally there is the Grant committee. There are several grants that we could take advantage of. Question on informing members to volunteer for the committee. Should send out an Eblast for volunteers as to have members chosen by February meeting may be hard. Question about members without Email. He is not worried about the members that don't have email as the committees will need to communicate with each other often through email. Bob indicated the club has been around for 60 years with one employee.

**Badges, Jack DeMarre:** We print a new badge cover each year. Member has asked how close we are to getting a badge sticker instead of printing new covers. Will work in theory as Jack can turn off the Badge when needed. He can't start printing new badges until after member renewal deadline. With sticker renewal he only needs to replace badges when badge is lost or not working. Discussion followed on printing badge problems vs. using stickers. This year he would work on design of sticker. Color coded sticker would be used. He could print on proxy card the initial issue and not use badge cover. This year will get new badge cover. He will use up current stock first. Then start new procedure after. Bob added that not spending money is the same as adding to the revenue. Bob asked if anyone had opposition to the new procedure. Hearing none, Jack will start the design process this year with new procedure to follow.

**Grants, Herb:** Had a list of items Grants could be used for last year. He has left over items that could be used this year. He listed the ramp on the Marah building that would be a large expenditure. Dean Cody added a roof on the Short range would be nice. Dean also said the Ramp should be done this year. Austin commented that any contractor in the club could be asked about the project. The ramp must meet ADA requirements.

**Assistance needed:** Bob indicated he would like to see assistants to Treasure and others to help in the large volume of work needed in their jobs.

**Newsletter Mailing, Bob:** Currently we mail the newsletter to 58 members without email. How can we reduce the cost of mailing the newsletter? Dean Cody stated he has seen other organizations have the members pay an addition fee to receive the mailed newsletter. Bob added even the government has switched to Email. Discussion followed. Looked at advertising in the newsletter that is currently free to members. Dean commented to just add a yearly fee at a reduced rate. Currently Pati Leo has spent lots of hours for several years in mailing the newsletter. Bob would like the next newsletter to inform the members mailed of the cost of sending the newsletter. They have an option to pay to continue or have another member print a copy for them. Will be putting item in newsletter.

## OGC Board Meeting January 10, 2024

Meeting started at 8:00 PM by President Bob Lawrence

There were 12 members present.

A quorum of Board members was present.

**Secretary Report:** A Motion was made to accept the minutes from the November 2023 Board meeting were approved as printed in the newsletter. Seconded, with majority members present voting aye. Bob questioned has anyone ever made corrections to the newsletter. Yes they have and the corrections are noted in the next newsletter.

**Old Business:** None

**New Business:**

**Insurance Audit:** Bob and John have discussed this a little. In order for our employee dishonesty policy to be renewed there must be internally audited financials for 2023. John has his volunteer hours for the next 40 years already but he is working on the Audit. John stated the biggest item coming into play is income and getting it assigned to the right bucket. The numbers are there and John does not believe the insurance company knows if this was trap income or what. They are only concerned with, we made x amount of money and we spent x amount of money, and he has that information. Bob indicated he would like the report for the insurance sent within the next week or so.

**Credit cards and recurring payments:** John is trying to get things sorted as everything is tied up in Elong Financial in Daryll's name and John is locked out. He has spent about 2 hours on the phone talking to 7 people to get documentation sent to him to get authorization for new cards and to cancel old cards. That was supposed to get mail to him 8 days ago but has not received it. Once this is done then he will apply for new cards for Dean and Teresa. The cards won't have big limits on them but if items are needed the card will be used. This will eliminate them using their own money and the paperwork to reimburse them. He will limit the people who have club credit cards to only people that need it. He has found there where 4 digit checks written to club members for reimbursement but there is no documentation to support the checks. John is trying to make the accounting more efficient and make it easier on everyone. Bob asked if anyone has the need to have a credit card. Teresa indicated Scott, who does the vending machines, has a card and does submit excellent documentation for his purchases. There were no others that asked for a card. John is trying to manage our bills so there is no individual assigned to the bill rather it should be assigned to accounts payable for Oakdale Gun club. A question was asked about rewards from points on the credit cards. Those points could be used for prizes for events at the club. Per state guidelines Board members can't use the points to profit from the club.

**Chief Instructor updates:** Bob reported for Dan. New member classes are scheduled for January 28 and February 8. Dan will use Sign-up-genius to hopefully get two thirds or more of the new members to attend. Bylaws and Policy manuals will be emailed to the new members as all have Email addressed. He will schedule follow up classes for any new members that have missed. John will be looking for volunteers to help in tours and the training. There needs to be an assessment of the equipment needed in the classroom prior to the classes as there have been some problems in the past. Bob ordered a new cable for the projector. The current projector is old and connecting to it has been a problem in the past. Austin suggested a new large screen could eliminate the projector and be more user friendly. Bob indicated that could be the simplest solution.

**Director Positions:** Bob, it would be very helpful if there were job descriptions for all Director positions with SOP and list of tasks. He would like something from everyone within a month.

**Newsletter:** Bob would like a change to the newsletter to show the meeting schedule on the front page and make it prominent.

**Advertising in the newsletter:** Bob, what are the current rules for ads in the newsletter? They are currently free. John indicated the State did mention the newsletter ads as taxable items. Discussion followed on what we could do. We could ask for donations for ads in the newsletter. Bob said he did not think anyone would balk at \$100 per year. Now it is members only perk. Per the IRS 65 percent of our income must come from the membership dues for 501 companies. John said we need to bring in more money however we can as we have spent a bunch of money in the past, but membership is down and other revenue is down. He will be looking closely at any expenses.

**School update:** it was noted there was a question about water needed for the school to be built. The DNR has said there is enough water for Lake Elmo to support the new school.

**Trap Position:** Dean Cody indicated we need a trap director. Bob asked about the job description. Teresa said the big problem is they must be at the club to manage the operation. Ideas were to have assistants for the trap as a team to run the trap operation. Bob indicated there is a problem with the POS system access so people could use credit cards to shoot trap. There needs to be people trained to use the POS system. He did not know if using an iPad would be an option. There are a number of problems using our POS system that need to be worked out.

**Joel Charchenko:** Just had a class last night for in person DNR Firearm Safety. There will be another in person class scheduled for May. There is a DNR Firearm Safety Instructor class on January 20 with 31 people signed up. They are not all OGC members for this class. Bob asked about classes at OGC and if revenue is from the class and change for members vs nonmembers. Teresa indicated the classes are charged \$10 per person for classroom use and \$20 for nonmembers shooting on the range. Bob asked about how the revenue is recorded. Bob said he is working on it now. Discussion followed on how revenue is recorded, and updates need to be made to that process.

**Revenue Committee:** Austin, during the revenue committee meet they discussed having a person come in and have drone work. He explained there is a member in the club with the qualification to come in with a Drone for our needs. Austin asked him what the charge would be for his services and the answer was \$2,250. Austin explained what the drone would be used for at the club. The member did not get his service hours last year. He is willing to trade his service hours for the drone service to be able to stay in the club. Discussion followed on trading hours for volunteer work.

**Motion** made to ignore the February 1 cut off for the Drone person and have him appear at a later meeting. Second by Dean, majority voting Aye, no opposed.

**Motion to adjourn** 9:05 PM Meeting adjourned.

## OFFICIAL UPDATES TO OAKDALE GUN CLUB BYLAWS AS OF DECEMBER 16, 2023

Article VI: Officers, Board of Directors, Executive Committee and Employees  
update to Item C:

A person must have been a member of Oakdale Gun Club for one consecutive year in order to be eligible to be elected to a position on the Board of Directors. A member who has been voted off the Board of Directors through the Expulsion and Suspension Process as provided for in Article VIII shall not be eligible to be elected to the Board of Directors again until a minimum of five consecutive years of membership has passed. All officers and directors of the club, except the immediate past president, must be elected by a majority vote by secret ballot of the eligible voting members at the annual meeting of the club as specified in Article V (C) of these Bylaws.

Article VIII Expulsion and Suspension  
Remove Item E NRA Suspension.

## OFFICIAL UPDATES TO OAKDALE GUN CLUB POLICY AS VOTED AT THE ANNUAL MEETING OF DECEMBER 16, 2023. THESE ARE UPDATES TO THE MEMBER HANDBOOK.

Safety is our No. 1 priority. No one will be allowed to jeopardize firearm safety.

Oakdale Gun Club Confidential Information Policy for Board of Directors and all Membership of the Oakdale Gun Club. It is the policy of the Oakdale Gun Club that all club membership will not disclose confidential information belonging to, or obtained through their affiliation with, the Oakdale Gun Club to any person outside of membership, or any business and professional associates, unless the Oakdale Gun Club has authorized disclosure. This policy is not intended to prevent disclosure where disclosure is required by law. Preservation of privileged information: Board members and all club membership shall not divulge, transmit or distribute any confidential or proprietary information outside of the club's membership without Oakdale Gun Club's authorized disclosure. Any disclosure of the Oakdale Gun Club Confidential and Proprietary Information may put the club at risk. Proven violations may have consequences and will be handled by the Executive Committee. The following indicates important confidential and proprietary information. This policy may be updated to cover additional information deemed confidential and proprietary. This policy will reside in the Member Handbook. • Bylaws are considered a legal document that dictates how the organization must be governed thus are a confidential document of the club. • The club's financial, legal and security information, insurance policies, tax documents, member issues/discipline, employee records/ compensation, the contents of the membership E-Bulletin/Newsletter which contains board and member meetings, contact lists, project info and firearm sales, all policy and procedural manuals, the member handbook, project plans, and contracts. • Marketing tools such as the club's website, club brochures and classroom materials are intended for public viewing and not considered confidential info of the club.

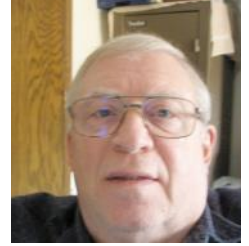

## Postal Match

### What is the Postal Match?

The OGC Postal Match is great fun, gives shooters a goal to achieve as well as a reason to practice and improve his / hers shooting skills. The term "Postal" refers to the manner by which targets are exchanged, the US Mail. The Postal Match works like this;

Shooters choose only the events they want to participate in. Fee per event is \$5.00 and the deadline for entries is June 15, 2024.

#### The events are:

- Handgun (Revolver) @ 10 Yards, open sights, timed fire.
- Handgun (Autoloader) @ 10 Yards, open sights, timed fire.
- Handgun (Rimfire) @ 10 Yards, open sights, timed fire.
- Handgun Unlimited 100 Yards, any caliber, any sight.
- Lever Action @ 100 Yards, scope, timed fire.
- Lever Action @ 100 Yards, iron sights, timed fire.
- Rimfire Rifle @ 100 Yards, scope, timed fire.
- Rimfire Rifle @ 50 Yards, open/iron sights, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, scope, timed fire.
- Hunting Rifle (.270 Min Cal) @ 100 Yards, iron sights, timed fire.
- Varmint Rifle @ 200 Meters, scope, timed fire.
- Varmint Rifle @ 200 Meters iron sights, timed Fire
- Black Powder Cartridge Rifle @ 200 yards. Scope, timed fire.

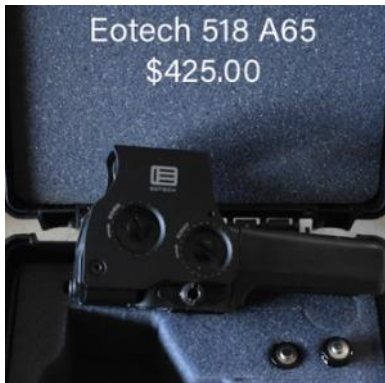

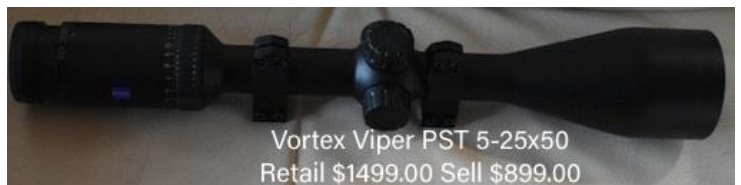
